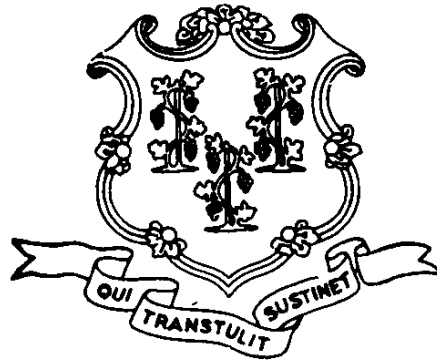

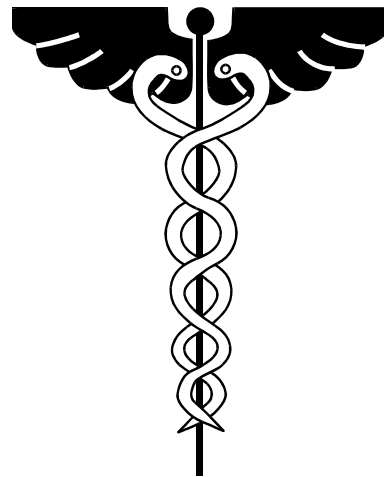

# SECTION II

## CONTROLLED DRUG VIOLATIONS & PENALTIES



According to Section 21a-240(28) of the Connecticut General Statutes, manufacture means the production, preparation, cultivation, growing, propagation, compounding, conversion or processing of a controlled substance, either directly or indirectly by extraction from substances of natural origin, or independently by means of chemical synthesis, or by a combination of extraction and chemical synthesis, and includes any packaging or repackaging of the substance or labeling or relabeling of its container. It does not include by a practitioner as an incident to, his administering or dispensing of a controlled substance in the course of his professional practice or by a practitioner, or his authorized agent under his supervision, for the purpose of, or as an incident to, research, teaching or chemical analysis and not for sale.

**Drug Paraphernalia**

Section 21a-270 of the Connecticut General Statutes

Factors to be considered by court or other authority in determination. In determining whether any object or material listed in subdivision (20) of Section 21a-240 shall be deemed “drug paraphernalia” a court or other authority shall, in addition to all other logically relevant factors, consider the following:

- a.) Statements by an owner or by anyone in control of the object concerning its use;
- b.) The proximity of the object to any controlled substances;
- c.) The existence of any residue of controlled substances on the object;
- d.) Evidence of the intent of an owner, or of anyone in control of the object, to deliver it to persons whom he knows or should reasonable know, intend to use the object to facilitate a violation of this section, subdivision (20) of Section 21a-240 and Sections 21a-263, 21a-267 and 21a-271;
- e.) Instructions, oral or written, provided with the object which explain or depict its use with a controlled substance;
- f.) Descriptive materials accompanying the object which explain or depict its use with a controlled substance;
- g.) National and local advertising concerning its use;
- h.) The manner in which the object is displayed for sale;
- i.) Whether the owner, or anyone in control of the object, is a legitimate distributor or dealer of tobacco products;
- j.) Evidence of the ration of sales of the object to the total sales of the business enterprise;
- k.) The existence and scope of legitimate uses for the object in the community;
- l.) Expert testimony concerning its use.

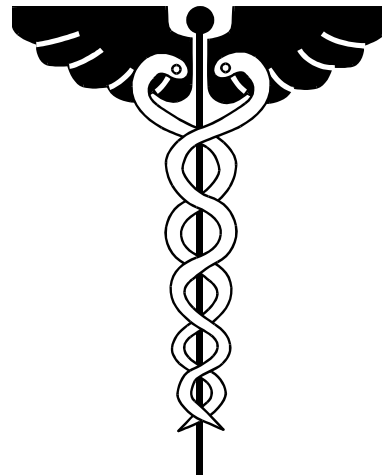

**Summary of Federal Methamphetamine Statutes**

Anti-Methamphetamine requirements apply to all single and multi-ingredient products containing Pseudoephedrine

Logbook and identification requirements do not apply to sale of 60mg or less of Pseudoephedrine

Comply by April 08, 2006

- 3.6 gram daily sales limit
- 9 gram monthly purchase limit
- All non-prescription Pseudoephedrine and Ephedrine must be in blister packaging
- Mail-service pharmacy must verify patient's identification before shipping product and 7.5 gram 30-day sales limit

Comply by September 30, 2006

- Placement of products behind a counter or in a locked cabinet
- Maintaining a written or electronic logbook
- Photo identification must be shown at purchase and sign the logbook
  - The product name
  - The quantity sold
  - Name and address of the purchaser
  - Date and time of sale
- Retail staff must be trained; Self-certify to the United States Attorney General that their sales personnel have been trained as required by regulations (yet to be promulgated)
- 7.5 gram 30-day sales limit for mobile sellers (i.e. kiosks in airports)
