# Reinstatement Instructions for Individual Real Estate Broker <u>Expired March 31, 2021</u>

- A real estate broker legal entity license may be reinstated provided a completed reinstatement form and all applicable fees are submitted **not later than two years after the date of expiration of the license.**
- Reinstatement of a broker's license will only be accepted if all applicable fees are paid to bring the license to the current year and required continuing education is complete. Any such reinstated license shall expire on the next succeeding November 30<sup>th</sup>.

#### **Reinstatement Fees:**

A total reinstatement fee of \$1,077 must accompany the completed reinstatement application. Payment must be in the form of a check or money order made payable to "Treasurer, State of Connecticut."

### **Continuing Education:**

 You must have completed your required Continuing Education Courses in accordance with Connecticut General Statutes, Section 20-319 and provide proof of compliance to be eligible for reinstatement.

#### **Broker Legal Entities:**

 All Corporations, Limited Liability Companies, Partnerships or Partnerships must complete the Broker Legal Entity Reinstatement Form available on our website www.ct.gov/dcp.

### Real Estate Broker Continuing Education Requirements 2020 - 2022

In accordance with Connecticut General Statutes, Section 20-319, Continuing Education is due on even-numbered renewal years to be eligible for reinstatement.

#### **Continuing Education Options:**

- Complete 12-hours of Continuing Education courses at an approved school (online courses are available). The courses shall consist of the following:
  - 1. Two three-hour classes for the 2022 Mandatory CE Requirements:
    - "CT Real Estate Law for Brokers and Salespersons"
    - "Understanding and Preventing Racial Bias in Real Estate"
  - 2. 6 hours of real estate elective courses

#### OR

Pass the Connecticut Continuing Education Examination. To take the exam, contact PSI Examination Services at <a href="www.psiexams.com">www.psiexams.com</a> or 1-800-733-9267 to schedule an exam appointment.

If you passed both portions of the Connecticut Broker licensing examination between April 1, 2020 and March 31, 2022 you do not need to take continuing education courses for 2022. Your PSI Examination score reports will reflect the examination passing date.
