Legal Matters

DN 08-1074 Rite Aid Pharmacy #10388 did not have active pharmacy manager for several months; PIC documented was on medical leave. Pharmacy also reduced the hours of prescription department without approval. Proposed recommendation is a civil penalty of \$8,000. Commissioner Goodmaster motioned, seconded by Commissioner Mulvihill and passed a vote of 5-0 accepting the proposed agreement.

DN 08-1073 Pharmacist Dean Woodruff refilled legend drug prescriptions for pharmacy employees without obtaining authorization from practitioner. Proposed agreement is for two-week suspension, one-year probation and \$2,000 civil penalty. *Commissioner Beaudin motioned, seconded by Commissioner Goodmaster and passed a vote of 5-0 accepting the proposed agreements.*

DN 08-1224 PTN using PIXIS machine, on multiple occasions, removed percocet from machine, but there is no record. Recommendation is for a summary suspension and schedule a hearing. *Commissioner Beaudin motioned, seconded by Commissioner Mulvihill and passed a vote of 5-0 accepting the proposed agreement.*

Review and discussion of Memorandum dated September 16, 2008 re: CGS Sections 20-615(a) and 21a-249(k) – Commissioner Summa suggests a meeting be held at 9 a.m. on October 29, 2008 with himself, Sr. Agent DeStefano, Attorney Schwane, Agent Sylvestre, Commissioner Mulvihill and Division Director John Gadea.

Review and discussion of **Memorandum dated September 16, 2008 re: CGS Section 20-612** – proposal denied. Regarding CGS 20-612 Commissioner Goodmaster motioned, seconded by Commissioner Mulvihill and passed a vote of 3-1 denying the proposal.

Hearing

DN 08-926 James Beaumariage of Familymeds Specialty Pharmacy due to alleged violations of the provisions of the Connecticut General Statutes related to pharmacy. The hearing is postponed due to serious medical issue. However, this issue may be resolved by agreement.
