Commissioner Michelle Seagull welcomed the Board as the newly appointed commissioner of consumer protection. Commissioner Seagull introduced Julianne Avallone, Director of the Legal Division and Paulette Annon, legal counsel assigned to the board.

Attorney Julianne Avallone advised the Board that their proposed changes to the regulations are complete and ready to begin the process for review.

The Board inquired as to whether or not that the statutes should be revised prior to proposing the legislative changes to the regulations. Attorney Avallone stated that in 2015/2016 the legal division was charged in working with the boards and commissions to update regulations. In April of this year they learned of the board's desire to make statutory changes. Any changes in statutes must be in the pipeline during the fall prior to each legislative session. Therefore, there is no chance of making the statutory changes until the 2018 Legislative Session.

Chairman D'Andrea inquired if the final draft of the regulations be forwarded to the board members for review.

Attorney Avallone stated that she will forward the proposed changes to the regulations to the Board administrator to forward to the board members. The Board should provide any recommended changes to the regulations by June 30th.

Attorney Avallone stated that if the Board wishes to put these changes on hold for the time being, please let her know the consensus of the Board on how to proceed.
