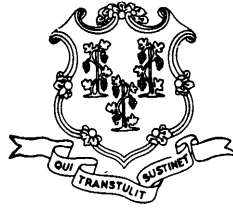

**New Home Construction Contractor Late Renewal Form**

- **This form can only be used to renew a registration not later than 6 months after expiration. After March 31<sup>st</sup>, a new application is required.** The registration number you wish to reinstate must be entered on this form.
- Effective July 1, 2017, the fee to renew shall be the same as the original application but charged on a pro-rated basis. All renewals received after September 30<sup>th</sup> are subject to the \$72.00 late fee.
- The submission dates and fee (including late fee) to renew a registration are as follows:

<b>October 1<sup>st</sup> – December 31<sup>st</sup></b>	<b>January 1<sup>st</sup> – March 31<sup>st</sup></b>
<b>Total fee: \$702.00</b>	<b>Total fee: \$612.00</b>

- If you have an active Home Improvement Contractor registration under the same legal entity (same name), the submission dates and fee (including late fee) are as follows:

<b>October 1<sup>st</sup> – December 31<sup>st</sup></b>	<b>January 1<sup>st</sup> – March 31<sup>st</sup></b>
<b>Total fee: \$492.00</b>	<b>Total fee: \$432.00</b>

- Payments must be in the form of a check or money order made payable to *“Treasurer, State of Connecticut.”* The effective date of the registration will be the date the completed form and fee are approved by this office. All registrations expire biennially on September 30<sup>th</sup> on every odd-numbered year.
