

## Real Estate Instructions for Reciprocal State Applicants

### Requirements:

- **Written Examination:** An applicant *must* have passed a national uniform written examination in the reciprocal state at the time of obtaining their license.
- **Active License:** An applicant *must* have an active license in good standing within the reciprocal state.
- **Certification of License History:** A certification of license history is required from the licensing authority in *every* state in which you currently hold or have held a real estate license. The reciprocal state must confirm you took an examination in that state.
- **Salespersons:** Your sponsoring broker must have an “Active” Connecticut license.

Please be sure you have read and understood all licensing requirements, rules and regulations available on our website at [www.ct.gov/dcp](http://www.ct.gov/dcp) prior to submitting your application.

### Fees:

- **Salesperson: \$385.00** (\$80 application fee\*; \$285 initial license fee; \$20 guaranty fund fee\*)
- **Broker: \$705.00** (\$120 application fee\*; \$565 initial license fee; \$20 guaranty fund fee\*)

A check or money order in the amount indicated above made payable to “**Treasurer, State of Connecticut**” must accompany the application. Application fees are non-refundable.

*\*only the application fee is required at the time of application for those candidates who need to take the State Portion of the CT Real Estate Examination. The Guaranty Fund is a one-time fee. If you paid the Guaranty Fund fee as a salesperson, it's not required for the broker license.*

### Examination:

All applicants applying by reciprocity from the following states: *Florida, Illinois, Indiana and Ohio* or applicants who have *not* taken an examination in a reciprocal state are required to take the State Portion of the Connecticut Real Estate Examination administered by PSI.

- After the application is reviewed and approved, you will receive an Examination Eligibility Postcard from PSI Examination Services with instructions to register and schedule the examination. PSI can be contacted at 1-800-733-9267 or [www.psiexams.com](http://www.psiexams.com).

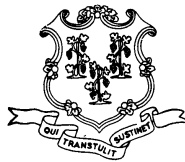
### Legal Entities:

If you plan to do business as a legal entity you must obtain a broker license in the name of that legal entity. Follow these application procedures first; then AFTER you have passed the CT Real Estate Broker Licensing Exam, go to [www.ct.gov/dcp](http://www.ct.gov/dcp) and download the New Legal Entity Application and submit with initial license fee and your passing CT broker exam score report.
