	<b>07-1212</b> Walgreens #3359 allegedly permitted unregistered Technician, violated the Pharmacist-Technician ratio and breached patient confidentiality.
	(total penalty of \$3,000 recommended)
	<b>07-1295</b> Familymeds, Inc. (Arrow Express) was investigated for possible violations regarding kiosks located in or near medical facilities. Kiosks were discontinued after a short period of use. (\$4,000 fine recommended)
	<b>07-1171</b> Walgreens #3827 was cited during a routine inspection for not having proper prescription error reporting information on receipts, written QA program policies in the pharmacy; signatures of Technicians and Pharmacy Manager in training records and all required pharmacist signatures for controlled substance refill log. During follow-up inspection, some violations were corrected. (\$1,000 penalty recommended)
	<b>07-1098</b> Jeff R. Ryan committed two prescription errors within a three-year period.
	(Letter of reprimand and CE course is recommended)
