# Legal Matters

**DN 11-702** Drug Control investigated a prescription error and noted that the pharmacist, James Rawlings (PCT.4747), who committed the error failed to initiate a Quality Assurance review. The department is recommending a Letter of Reprimand and the continuing education course on the prevention of prescription errors. *A motion was made by Commissioner Inguanti, seconded by Commissioner Beaudin and a vote of 5-0 was passed accepting the Department's recommendation.* 

**DN 11-772** This pharmacy technician, Diovenny Mejia (PTN.9503) surrendered his registration in March of 2011 for diversion of a small quantity of non-controlled substances. The Department met with the technician and is satisfied that reinstatement of his registration is appropriate. The proposed agreement calls for a two year probation and requires him to give a copy of this agreement to any pharmacy employer during the probationary period

The following pharmacies breached patient confidentiality by giving a prescription to the wrong person. Each pharmacy is paying a \$1000 civil penalty.

Chairman Summa stated that he spoke with Jerry Padula (DCP's Legislative Liaison) prior to this meeting and stated Attorney Schwane and Jerry Padula will obtain further information regarding the status of the pending pharmacy regulations and provide this group with an update.

## Request for CE Waivers, etc.

Teresa Corcoran (PCT.7128) is requesting 7 credits be considered for her attendance at the DPH-sponsored "Responding to a Terrorist Attack: Training for the First Responder" program she attended in March 2011. *This request has been approved.* 

Colleen Dalrymple (PCT.11145) is requesting for a waiver of her 2011 CE credits as she's enrolled in a Masters program at the University of Florida. *The Commission is requesting additional info/transcript from the pharmacist.* 

## **Miscellaneous**

### **Teen Rx Abuse Program**

Commissioner Goodmaster provided an update about the teen prescription drug abuse program. Approximately five letters have been written to various boards of education and high schools to no avail. Attempts to contact schools will continue.

### **Drug Shortages**

There are reported shortages of morphine, phentenol and other controlled drugs as the FDA has put a limit on the amount of these drugs that may be produced annually and it isn't unusual to find these drugs are scarce this time of year.
