Legal Matters

Docket Number 13-835 Sitner-Medvedovsky

Attorney Lynn Fiore presented this case. Commissioner Inguanti 'stepped down'. This case involved the pharmacist committed three prescription errors within a three-year period, and in this instance this pharmacist returned the bottle of one of these dispensed prescriptions to the drug stock shelves. Following a compliance meeting, this agreement settles the matter by way of payment of a \$500 civil penalty, completion of the continuing education course, and issuance of a Letter of Reprimand.

Commission Action: Commissioner Beaudin moved, seconded by Commissioner DeFazio and passed by a vote of 5-0 to accept and approve the aforementioned settlement agreement.

Docket Number 14-425 Marc lannaccone

Attorney Lynn Fiore presented this case. No Commissioner 'stepped down'. This case involved this pharmacist committed a prescription error that also resulted in a breach of patient confidentiality. The investigation determined that pharmacist also failed to initiate the process to complete a Quality Assurance review. The agreement calls for a \$500 civil penalty, completion of the continuing education course, and issuance of a Letter of Reprimand.

Commission Action: Commissioner Inguanti moved, seconded by Commissioner Goodmaster and passed by a vote of 6-0 to accept and approve the aforementioned settlement agreement.

Docket Number 14-457 Una Paek

Attorney Lynn Fiore presented this case. No Commissioner 'stepped down'. This case involved this pharmacist committed a prescription error in which a customer's confidential pharmacy information was disclosed. The agreement calls for a \$500 civil penalty and completion of the continuing education course related to prescription errors.

Commission Action: Commissioner DeFazio moved, seconded by Commissioner Chisolm and passed by a vote of 6-0 to accept and approve the aforementioned settlement agreement.

Docket Number 14-530 CVS #377

Attorney Lynn Fiore presented this case. Commissioner Inguanti 'stepped down'. This case involved Drug Control conducted a reinspection of this pharmacy after an initial inspection found multiple violations. The reinspection found some of the initial violations still uncorrected. In similar cases, the Commission of Pharmacy has assessed a civil penalty of twice the usual penalty for the specific violation (once for the first inspection and once for the second inspection). This agreement calls for a \$12,000 civil penalty (\$2,000 x 6 violations found on reinspection).

Commission Action: Commissioner Goodmaster moved, seconded by Commissioner DeFazio and passed by a vote of 5-0 to accept and approve the aforementioned settlement agreement.

Docket Number 14-554 Lynda Rowland

Attorney Lynn Fiore presented this case. Commissioner Inguanti 'stepped down'. This case involved this pharmacist filled prescriptions for her and family without having legitimate prescriptions. After a lengthy investigation and following a compliance meeting, the Department felt that not all of the allegations could be fully supported. By way of this agreement the pharmacist agrees not to be the dispensing pharmacist for any prescriptions for herself, her spouse, or her children, except in immediate medical emergency.

Commission Action: Commissioner DeFazio moved, seconded by Commissioner Carbray and passed by a vote of 5-0 to accept and approve the aforementioned settlement agreement.
