Miscellaneous Legal Matters

Attorney Antonio Santoro requested that three new dockets 15-585, 16-47, and 16-166, be added to the agenda. Commissioner DeFazio moved, seconded by Commissioner Carbray and passed by a vote of 6-0 to accept the above mentioned dockets to the agenda.

There was a high level discussion with Attorney Antonio Santoro and Legal Director Julianne Avallone, about the future procedures of step-down's with the commission.

Legal Matters

Docket Number 15-585 and 16-47 Vital Care of Connecticut, Inc. and Leyla K. Sokmen

Attorney Antonio Santoro presented this case. Commissioner Inguanti 'stepped down'. This case involved The Licensees have been investigated for the following:

- (a) failing to conduct a biennial inventory of all controlled substances on hand;
- (b) failing to maintain effective controls against theft or diversion evidenced by an audit showing controlled substance losses;
- (c) failing to follow prescription requirements by not filing chronologically the date of dispensing on the sticker/label placed on the prescriptions;
- (d) failing to sell or dispense controlled substances in good faith in that there were inconsistences in the date dispensed listed in the computer records in regards to the date data was entered and the date billed to the insurance company; the date the prescription was prepared and the date documented on the prescription record itself;
- (e) performed or was a party to a fraudulent or deceitful practice or transaction in that several Schedule II controlled substance prescriptions were not filed chronologically by date;
- (f) performed or was a party to a fraudulent or deceitful practice or transaction in that the dates of prescriptions dispensed were altered;
- (g) performed or was a party to a fraudulent or deceitful practice or transaction in that prescriptions were dispensed prior to the date indicated by the prescribing practitioner thereby being invalid;
- (h) performed or was a party to a fraudulent or deceitful practice or transaction in that several Schedule II prescriptions from out of state practitioners were dispensed;
- (i) performed or was a party to a fraudulent or deceitful practice or transaction in that several Schedule II drugs were dispensed earlier than legally permitted;
- (j) performed or was a party to a fraudulent or deceitful practice or transaction in that several of the same Schedule II prescriptions, as prescribed by the practitioner, were dispensed twice on the same day;
- (k) performed or was a party to a fraudulent or deceitful practice or transaction in that several Schedule II prescriptions were dispensed by practitioners who recently voluntarily surrendered their Connecticut controlled substance registration;
- (I) failed to submit a DEA 106 Theft/Loss of controlled substance form, and; (m) failed to obtain a fictitious trade name certificate.
- This agreement calls for a \$60,000 civil penalty

Commission Action: Commissioner DeFazio moved, seconded by Commissioner Beaudin and passed by a vote of 5-0 to accept and approve the aforementioned settlement agreement.

Docket Number 15-766 CVS #1060

Attorney Antonio Santoro presented this case. No Commissioner 'stepped down'. This case involved licensee has been investigated by the Drug Control Division of the Department of Consumer Protection for failing to file controlled substance prescriptions chronologically and sequentially. This agreement calls for a \$6,000 civil penalty.

Commission Action: Commissioner DeFazio moved, seconded by Commissioner Carbray and passed by a vote of 6-0 to accept and approve the aforementioned settlement agreement.

Docket Number 16-58 VaxServe, Inc.

Attorney Antonio Santoro presented this case. No Commissioner 'stepped down'. This case involved Registrant has been investigated by the Drug Control Division of the Department of Consumer Protection related to a situation involving certain products delivered by a carrier performing deliveries in the state of Connecticut on behalf of the registrant being stored, kept or held by the carrier under conditions contrary to the cautionary label statements on the package. This agreement calls for a \$2,000 civil penalty.

Commission Action: Commissioner DeFazio moved, seconded by Commissioner Beaudin and passed by a vote of 6-0 to accept and approve the aforementioned settlement agreement.

Docket Number 16-87 The Medicine Shoppe

Attorney Antonio Santoro presented this case. No Commissioner 'stepped down'. This case involved Licensee has been investigated by the Drug Control Division of the Department of Consumer Protection for the following:

- a.) The name of the pharmacist manager was not conspicuously posted within the prescription department of the pharmacy, or in immediate proximity to it;
- b.) A written copy of the quality assurance program was not maintained on the pharmacy premise and readily available to all pharmacy personnel and the Department of Consumer Protection;
- c.) A sign stating "This pharmacy may be able to substitute a less expensive drug product which is therapeutically equivalent to the one prescribed by your doctor unless you do not approve" was not posted;
- d.) Non-legend drugs were sold at retail in the absence of an approved pharmacy license or a permit to sell non-legend drugs; and
- e.) An inventory of all stocks of controlled substances on hand was not taken on the date the licensee first engaged in the dispensing of controlled substances. This agreement calls for a \$1,000 civil penalty.

Commission Action: Commissioner Beaudin moved, seconded by Commissioner DeFazio and passed by a vote of 6-0 to accept and approve the aforementioned settlement agreement.

Docket Number 16-91 CVS #1080

Attorney Antonio Santoro presented this case. No Commissioner 'stepped down'. This case involved Licensee has been investigated by the Drug Control Division of the Department of Consumer Protection for the following:

- a.) a pharmacist to pharmacy technician ratio greater than that permitted by Regulations of Connecticut State Agencies; and
- b.) failed to have all pharmacy technicians wear name tag or similar form of identification that clearly identified them to the public as pharmacy technicians. This agreement calls for a \$10,000 civil penalty.

Commission Action: Commissioner DeFazio moved, seconded by Commissioner Beaudin and passed by a vote of 6-0 to accept and approve the aforementioned settlement agreement.

Docket Number 16-118 CVS #1060

Attorney Antonio Santoro presented this case. No Commissioner 'stepped down'. This case involved Licensee has been investigated by the Drug Control Division of the Department of Consumer Protection for failing to have all pharmacy technicians wear name tag or similar form of identification that clearly identified them to the public as pharmacy technicians. This agreement calls for a \$1,000 civil penalty.

Commission Action: Commissioner Beaudin moved, seconded by Commissioner DeFazio and passed by a vote of 6-0 to accept and approve the aforementioned settlement agreement.

Docket Number 16-166 Gerald H. Ringel

Attorney Antonio Santoro presented this case. No Commissioner 'stepped down'. This case involved Licensee was investigated for failing to close and properly secure the prescription Department during the times when the pharmacist was not present. This agreement calls for a civil penalty of \$2,000
