Question: why aren't we testing more?

Commissioner indicated there is testing continues to increase. There was a walk through of Hartford Regional Center to begin testing all staff, on a voluntary basis, today. All of the area group home staff are invited for testing as well. Letter went out day before DS Council meeting regarding testing at Newington.

The Commissioner continues to engage with the National Association of State Directors of Developmental Services to explore strategies and exchange ideas with counterparts throughout the country regarding COVID-19 mitigation efforts and safety measures.

Hospital guidelines – DDS continues to work with DPH and the Governor’s office on additional guidance regarding a support person accompanying and individual with a disability to a hospital admission. A formal complaint on the issue was also made the federal Office of Civil Rights (OCR). Because of this OCR is now involved in creating and reviewing additional guidance. Anticipated release of further guidance is the end of the week.

Question asked regarding a parent or guardian accompanying a loved one to a doctors visits that are not routine. Commissioner Scheff responded that we continue to try and find creative solutions to this question including virtual options if direct participation is not appropriate. Commissioner recommended the team reach out to the doctor to identify preferences or protocols and work from there.

Krista Ostaszewski acknowledged that there was no legislative update as the Connecticut General Assembly has not yet scheduled special session.
