Subject: Woodstock Farms Pomegranate Kernels (Scenic Fruit) Recall

Please see attached information from FDA regarding the recall of Woodstock Farms Pomegranate Kernels. This product has the potential to be contaminated with hepatitis A and must be removed from sale. A distribution list obtained from FDA indicates that the product has been widely distributed to various stores in Connecticut. No illnesses associated with this product have been reported in Connecticut although CDC is currently investigating an outbreak of hepatitis A that identified the product as a result of a traceback investigation.

Attached are the FDA recall notice, photos of labels of the recalled product and the list of stores in Connecticut that are reported to have received the recalled product.

The Connecticut Department of Consumer Protection is aware of the recall and has issued a press release.

It is recommended that local health departments contact the stores on the list in their jurisdiction to ensure that they are aware of the recall and have removed any remaining product.

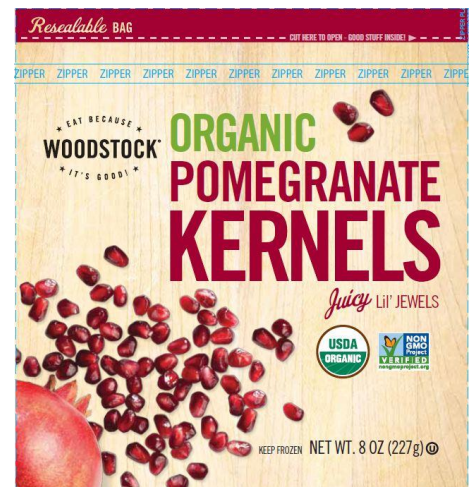
