A. Monthly Report

- Vicki reported that there was an anonymous donation of \$5000
- A call was received from a lawyer requesting an IRS letter be sent for the donor
- The donor does not want to be acknowledged
- Kristen requested that she be added to the Camp Harkness Fund email group
- Hope to have a calendar of events published
- Fall Festival on Sunday, September 27, 2015 made between \$600-700
 - o 6 vendors were onsite
 - Bouncy house was donated for the day
- Water features in the garden were built by Nick and a volunteer
 - o Some monies from the Fund were used less than \$400
 - Stones were utilized from the park
- Bey wondered what was going to be done with the \$5000 donation
 - Vicki responded that the funds would be used for programs, camperships and equipment (ex. Bench)
 - o Approximately \$9000-\$10,000 are currently available in fund
 - The plan is to purchase things the State cannot buy or anything small on the Master Plan that can be purchased by the Camp
 - o Compact surface and add stone dust under beach pavilion if cost is not prohibitive
 - o Picnic tables are not wheelchair accessible, even the ones that are supposed to be
 - Leaps of Faith (Sandy Hook) has an accessible table
 - Need to look into purchasing accessible tables

- o Campers also liked the Mobi-boat
- Kristen asked if a swing could be donated and installed?
 - Ernie said there would have to be an inspection of the tree and cable
