# The Southbury Training School Board of Trustees Met in Eugene Harvey's Conference Room at Southbury Training School, Southbury, Connecticut, on Monday, April 24, 2017.

Ann Dougherty, Vice Chair, called the meeting to order at 1:00 p.m.

#### COUNCIL ON DEVELOPMENTAL SERVICES

Diana Mennone, STS BOT Representative to the Council on Developmental Services, gave an update on the DDS Council meeting from March 16, 2017.

Izabella Pulvermacher, DDS Dental Coordinator, presented to the Council on oral health and dental services. Her role is to make sure that all 19,000 DDS individuals have quality basic oral health care. She provides training on tooth brushing to anyone who requests the training: group homes, individuals, families, staff, etc. Information can be found on the DDS website under the Advocates Corner. DDS has four dental clinics: STS, Ella Grasso, Lower Fairfield County and Norwich.

Jordan Scheff, Acting DDS Commissioner reported on the busy month testifying before the legislature. He also included in his report that the Abuse Investigations Division of the Office of Protection and Advocacy for Person with Disabilities (OPA) will be moving to DDS. Currently DDS already investigates most of our own programs. At STS and the Regional Centers, the Department of Public Health (DPH) has oversight of our investigatory process. There will be an informal transitional committee for the next six or eight months. Acting Commissioner Scheff will testify before the Public Health Committee on the move.

#### Medical Residents Tour STS

Helena Grabo, a clinician educator with the Yale-Waterbury Internal Medicine Residency Program at Waterbury Hospital, arrived on March 31<sup>st</sup> for a second tour of our facility with her internal medicine physicians in training. In addition to visiting the Medical and Dental Clinics, Cottage 42 and interviewing with Dr. Patel, Acting Medical Director, Eugene Harvey included Day Program and additional cottages. This group was very enthusiastic and encouraged with newfound knowledge of our facility and residents. A final tour will be conducted on May 26<sup>th</sup>.

#### Summer Camp

### Day Program

The Day Program Supervisor will be retiring July 1, 2017. A replacement is yet to be determined. Workshops and programs that continue include the selling of eggs, cut wood and Christmas trees. The Greenhouse remains open as well as the Thrift Shops. Lisa Nelson, Day Program Instructor, is now the Director of both thrift shops due to the retirement of Carole Grimes.
