Introductions by the members present were done. Collectively the four members in attendance represent many years of experience both within DDS and as Private providers.

Introduction:

- Peter handed out a variety of information for the committee to review. In particular, parts of the Wingspread Report tied to PBS were identified as something that would be most helpful for the members to review and to see what from the report will be pertinent for the committee's work.
- The committee was first formed in September of this year during the Communities of Practice Kick-Off. This is one of six sub-committees formed to develop recommendations to enhance supports that are provided to families.
- Also, in October, a Clinical Behavioral Retreat was held with the supervising psychologists facilitating six groups, which identified proposed action items focused on Positive Behavioral Supports for families.

Discussion Items:

1. Our mission might be to focus on the *best practices* for PBS that impact families and looking at the current behavioral trends in Connecticut. Also, viewing our committee as a resource to DDS to help keep individuals in their family homes.
2. Standardizing PBS Services: Developing a behavioral support plan template; it was drafted and briefly discussed at the October Retreat. It will be shared next with qualified behaviorists.
3. Recruiting new members to our committee with a goal of having 10 to 12 members representing a diverse population. Some ideas for recruitment were to reach out in the following areas: Self-Advocate Coordinators (Eva), Department of Education representative: Colleen Hayles (Peter), a residential staff representative and child psychiatrists (Debra), behavioral modification specialists (Peter), case managers (Eva), family members (Tacie). Debra will also contact Beth Caldwell in MASS to explore best practice information and representation (Coercion-free environments).

Personal Interests:

- Tacie: Building diversity in interests

- Eva: Developing a roadmap for improvement and a timeframe to accomplish our goals

Ideas for Possible Projects:

- As our unique project, could we help improve accountability for family-directed money and ensure quality by developing a *family satisfaction survey for PBS services*, besides relying on case management oversight?
- Developing a SharePoint Collaborative site (it would not be accessible to non-DDS personnel)
- Exploring the possibility of an externship site for bachelors and masters level students to help with the PBS Committee, especially providing education to families.

- Continue to develop a committee mission statement
- Discuss further development of unique projects
- Build recruitment!
