Information provided by the provider describing their agency:

Reliance Health (formerly Reliance House) partners with adults experiencing mental health, addiction, and intellectual disabilities to enhance their quality of life. Individuals can achieve enhanced quality of life and personal fulfillment by discovering passions, realizing dreams, and experiencing joy.

The Supported Living Program (SLP) has a long and effective history of partnering with adults with the dual diagnosis of an intellectual disability and mental illness in successful community living. The program is driven by the values of respect, individuality, and choice.

To meet the special needs of its members, the Supported Living Program is divided into two units: SLP I and SLP II.

SLP I provides residential supports, case management services, person centered planning, skill education and social and recreational activities. In addition, SLP members have access to other Reliance Health programs such as Teamworks Clubhouse, Career Services, Education, Respite, Penobscot Place, Budgeting Assistance, and Housing Resources.

Individually tailored and flexible supports include: *Assistance in living in one's own home within the community *Assisting with selection and direction of supports *Assistance in having presence and participation in the community *Achieving a maximum level of independence and health

Hours of direct supports vary based upon individual need. All referrals are received through the Connecticut Department of Developmental Services.

SLP II provides the same services as SLP I and is specifically designed to serve persons who are under the jurisdiction of the criminal court system. Individual supports are directed by the judicial system and the DDS Forensic team and include residential and day program services. All referrals are received through the Connecticut Department of Developmental Services Forensic Division.
