Various techniques are employed to help develop personal growth and potential; including Task Analyses, Shaping, Functional Communication, Functional Behavior Assessment, and Differential Reinforcement. BAC believes in an interdisciplinary-team approach to address obstacles and challenges to meet identified goals.

Career progression includes Director of Behavioral Health, DDS Facility Inspector, Vocational Rehabilitation Counselor, and Direct Support Professional.

Robert has a Bachelor of Arts degree major in Psychology, minor in Biology; Master of Arts in Community Psychology; and holds a Certificate in Applied Behavior Analysis.
