Living Innovations is a mission-driven and values-based organization committed to supporting people with disabilities to have a good life at home and in the community. Our web-site speaks to our values, and identifies the wide variety of creative supports provided by our agency. All of our Day and Residential services have a minimal reliance on a facility and are completely person-centered.

Living Innovations (LI) is a New Hampshire-based organization founded in 1996. We are currently serving over 1000 individuals and families in New Hampshire, Maine, and Rhode Island. Our entry into Connecticut in February 2017 is focused on residential home-sharing, Community Companion Homes (CCH).

Residential Support (CCH) Since our inception, LI has pioneered a Shared Living model of residential services, titled CCH in Connecticut. We are proud to be a leader in the innovative drive to support people with a wide range of abilities and needs to move from institutional and segregated staffed settings into a natural home. LI also supports individuals to successfully transition from their family homes to a CCH. We have recruited hundreds of Home Providers and have great experience with selecting safe and nurturing providers. Currently we support individuals residing, or receiving respite care, in well over 400 homes in three states.

Living Innovations carefully matches people with developmental disabilities with licensed Home-Providers. It is a choice for both parties to live together (not a “placement”). Participants are provided a family-like home, support, and guidance. Home Providers actively participate with individuals’ teams; keep many people connected to their families, and support individuals to meet the goals of their personal plans. LI ensures that the Home Providers have safe homes, ensure human rights, receive ongoing support and oversight, and maintain all standards for licensing
