Pathways To Success LLC is an agency specializing in clinical and therapeutic services providing supports and programs to individuals diagnosed with Intellectual Disorders / Developmental Disabilities and co-existing psychiatric disorders. Pathways To Success LLC focuses on increasing pro-social coping, increasing independence with daily living skills, maintaining relationships with family/friends, various providers and state agencies, inclusion within their communities, and identifying goals and objectives for future planning.

Clinical/Therapeutic Support Services include;

- Assessment and evaluation of behavioral and clinical need(s);
- Development of behavioral support plan that includes intervention techniques as well as teaching strategies for increasing new adaptive positive behaviors, and decreasing challenging behaviors addressing these needs in the individual's natural environment;
- Provide training to the individual's family and the support providers in appropriate implementation of the behavior support plan and associated documentation; and,
- Evaluate the effectiveness of the behavioral support plan by monitoring the plan on a monthly basis, and by meeting with the team one month after the implementation of the behavior plan, and in future three-month intervals. Supports will include any changes to the plan when necessary and the clinical team shall be available for questions and consultation.
