## Intent to Conduct Regulated Activities authorized by a Dam Safety General Permit

This notice is for use by person(s) intending to conduct an activity authorized by a DEEP Dam Safety General Permit. Complete and submit this form to the town clerk of each municipality affected by the proposed activity a minimum of two (2) weeks prior to initiating the activity (or 60 days prior for dam removal activities). A copy of the submitted form(s) showing the municipal stamp indicating receipt shall be included with the filing made to DEEP or submitted to DEEP independently for activities authorized under GP-014.
