

Helpful Hints for Creating Subscriber Agreements

Having the following information together before creating your Subscriber Agreement (SA) will help the process run more smoothly.



Signatory Authority

- for Request for a Hearing is the applicant, petitioner, respondent, or intervening party.
- is required to sign the Signatory Authority page printed with the Subscriber Agreement (SA) after the information is entered electronically.
There can be only one Signatory Authority.
- is, by default, a Subscriber and must also sign the Subscriber page printed with the Subscriber Agreement.



Subscriber

- is an individual duly authorized by the *Signatory Authority* to submit *Electronic Filings*. **There can be multiple Subscribers, such as persons, petitioners, companies or organizations applying for a permit/license, recipients of enforcement actions, or individual or organization interested in the outcome of a hearing.**
- must sign the Subscriber page printed with the Subscriber Agreement before it is mailed into DEEP for approval.

User Accounts and Usernames

- create User Accounts for the Signatory Authority and all Subscribers first, before beginning the Subscriber Agreement.
- input the username from the User Accounts in the Subscriber Agreement when prompted.

Agreement for using an eSignature to submit Electronic Filings to the Connecticut Department of Energy & Environmental Protection (“DEEP”) pursuant to Chapters 445, 446, and 449 of the General Statutes of Connecticut, and the regulations promulgated thereunder, (“Subscriber Agreement”). The Connecticut Department of Energy & Environmental Protection (“DEEP”), a state governmental agency, is the requesting party (“Regulated Person”), and the “Subscriber,” and the Regulated Person, as provided in the “Regulated Person Information” section of this Agreement, are the “Regulated Person” and the “Subscriber,” respectively.

B. Terms and Conditions

1. DEFINITIONS: Whenever used in this Agreement or any document to which this Agreement is attached, the following terms shall be defined as follows:

1.1 **Compromise.** When the eSignature is intentionally or unintentionally made available, including any theft or loss, to any other person, ordered by a Court of competent jurisdiction.

1.2 **Electronic Filing.** Refers to any permit application, permit or submitted electronically (using an eSignature) to DEEP pursuant to the General Statutes or regulations promulgated thereunder. Use of documents related to enforcement actions, including, but not limited to, Violation, may not be filed electronically with DEEP and there will be a Violation.

1.3 **Person.** Includes any individual, firm, partnership, association, liability company, municipality, agency or political or administrative entity.

1.4 **Personal Identification Number (PIN).** Assigned by the Connecticut Department of Energy & Environmental Protection (“DEEP”) upon acceptance of this Agreement; each PIN will consist of a unique combination of letters and numbers and shall constitute the electronic signature of a Subscribers.

1.5 **Regulated Person.** Any Person subject to Chapters 445, 446, and 449 of the General Statutes of Connecticut, and the regulations promulgated thereunder and who intends to submit documents to DEEP. A Regulated Person is identified in Section A of the Subscriber Agreement.

1.6 **Signatory Authority.** The individual submitting documents to DEEP who is a Regulated Person or represents the Regulated Person and has the existing authority to sign documents on behalf of the Regulated Person pursuant to, as applicable, RCSA § 22a-430-3(b)(2)(A), 22a-174-2(a), and/or 22a-449(c)-110 (incorporating 40 CFR § 270.11(a)).

The Signatory Authority has authority to sign this Agreement and may delegate authority to sign Electronic Filings to the Subscribers.

1.2 Electronic Filing: Refers to any permit application, permit modification, or other filing (using an eSignature) to DEEP pursuant to the regulations promulgated by DEEP and the Connecticut General Statutes or the regulations promulgated by the Connecticut DEEP. Under this Agreement, the term "eSignature" refers to the electronic signature of a Regulated Person or a Submitter.

1.3 Person: Includes any individual, firm, partnership, association, syndicate, company, trust, corporation, limited liability company, municipality, agency or political or administrative subdivision of the state, and any other legal entity.

1.4 Personal Identification Number (PIN): Assigned by the Connecticut DEEP, as may be applicable, following acceptance of this Agreement; each PIN will consist of a unique sequence of alpha-numeric characters, punctuation or symbols and shall constitute the electronic signature of a Submitter.

1.5 Regulated Person: Any Person subject to Chapters 445, 446c, or 446d of the Connecticut General Statutes or the regulations promulgated thereunder and who intends to submit Electronic Filings pursuant to this Agreement. The Regulated Person is identified in Section A of the Subscriber Agreement.

1.6 Signatory Authority: The individual submitting documents to DEEP who is a Regulated Person or represents the Regulated Person and has the existing authority to sign documents on behalf of the Regulated Person pursuant to, as applicable, RCSA § 52-22a-430-3(C)(A), 22a-174-2a(A), and/or 22a-449(c)-110 (incorporating 40 CFR § 270.116(a)). The Signatory Authority has authority to sign this Agreement and may delegate authority to sign Electronic Filings to the Submitter.
