

## Notice of Intent to Revise the State Implementation Plan (SIP) concerning the State of Connecticut's 2011 Periodic Emissions Inventory

The Commissioner of the Department of Energy and Environmental Protection (DEEP) hereby gives notice of intent to revise the SIP to add Connecticut's 2011 Periodic Emissions Inventory (PEI). The PEI has been prepared in satisfaction of sections 182(a)(1) and 172(c)(3) of the Clean Air Act.

The PEI quantifies air emissions for all categories of air pollution sources in Connecticut. This data will establish the baseline inventory year of 2011, as well as providing input data for modeling to support Connecticut's efforts to attain the ozone national ambient air quality standards and several other planning efforts.

This notice is required pursuant to 40 Code of Federal Regulations (CFR) 51.102. The 2011 PEI will be submitted to the United States Environmental Protection Agency for review and subsequent inclusion into the SIP.

A copy of the proposed PEI is available for public inspection during normal business hours from 8:30am until 4:30pm at DEEP's Bureau of Air Management, Planning and Standards Division, 5th Floor, 79 Elm Street, Hartford, CT. The PEI draft is also posted on DEEP's website at the following location:
