On September 3, 2019, Governor Ned Lamont issued <u>Executive Order No. 3</u> (E.O. 3) establishing the GC3 and strengthening Connecticut's commitment to transition to a decarbonized economy and enhance resiliency of the state's economic, cultural, and natural resources to the impacts of climate change. In 2020, the Council convened working groups, conducted a participatory process, and delivered the January 2021 Report: *Taking Action on Climate Change and Building a More Resilient Connecticut for All*, with 61 recommendations for near-term climate action. In December 2021, Governor Lamont signed Executive Order 21-3 implementing 23 executive actions reflecting 33+ recommendations of the GC3 and continuing the work of the GC3. In the fall of 2022, the Working Groups convened to monitor and report on the progress of the 2021 recommendations, including new opportunities for implementation with unprecedented federal funding for climate mitigation and resilience.
