Dear Mr. Thompson,

Thank you for the December 27, 2021, request for approval of a change to the Connecticut Coastal Management Program pursuant to the National Oceanic and Atmospheric Administration (NOAA) Coastal Zone Management Act (CZMA) regulations at 15 CFR part 923, subpart H.<sup>1</sup>

NOAA's Office for Coastal Management approves this change subject to the qualification noted below, and issues this decision.

NOAA's regulations require Connecticut to post this decision by the Office for Coastal Management for public notice on Connecticut's website.<sup>2</sup> The public notice should state that as of the date of this decision letter, the enforceable policies identified in the attached Table of Approved Changes shall be applicable in reviewing federal actions pursuant to the federal consistency requirements of the CZMA and its implementing regulations found at 15 CFR part 930.<sup>3</sup> Please send a copy of the public notice to the Office for Coastal Management for our records to close out this file.

## **PUBLIC AND FEDERAL AGENCY COMMENTS**

The Office for Coastal Management received eight comments on this program change submission. All commenters expressed their support for the Blue Plan and its incorporation into Connecticut's Coastal Management Program.
