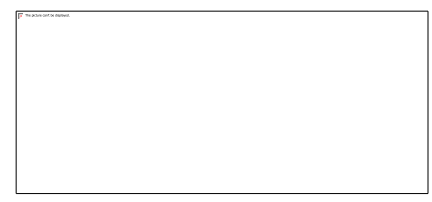

# Connecticut Weatherization Assistance Program - Purpose

- To increase the energy efficiency of dwellings owned or occupied by low-income persons .... and improve their health and safety, especially low-income persons who are particularly vulnerable.
- In Compliance with Federal Regulations:
  - 10 CFR 440 (Program)
  - 2 CFR 200 (Financial)
- In Compliance with State Rules and Procedures:
  - CT WAP Operations Manual (Program, Financial, and Technical)
  - CT WAP Field Guide (Technical)



# Weatherization Assistance Program State Plan - Federal Compliance

The State Plan is a component of CT's application to US DOE for implementation of the Weatherization Assistance Program for Low-Income Persons and documents:

- How CT WAP plans to ensure delivery of quality, effective services to households eligible for the Connecticut Weatherization Assistance Program (WAP)
- How CT WAP plans to continuously improve program effectiveness
- How CT WAP complies with 10 CFR 440 and 2 CFR 200 and State Rules and Procedures



# Connecticut Weatherization Assistance Program - Programmatic Update

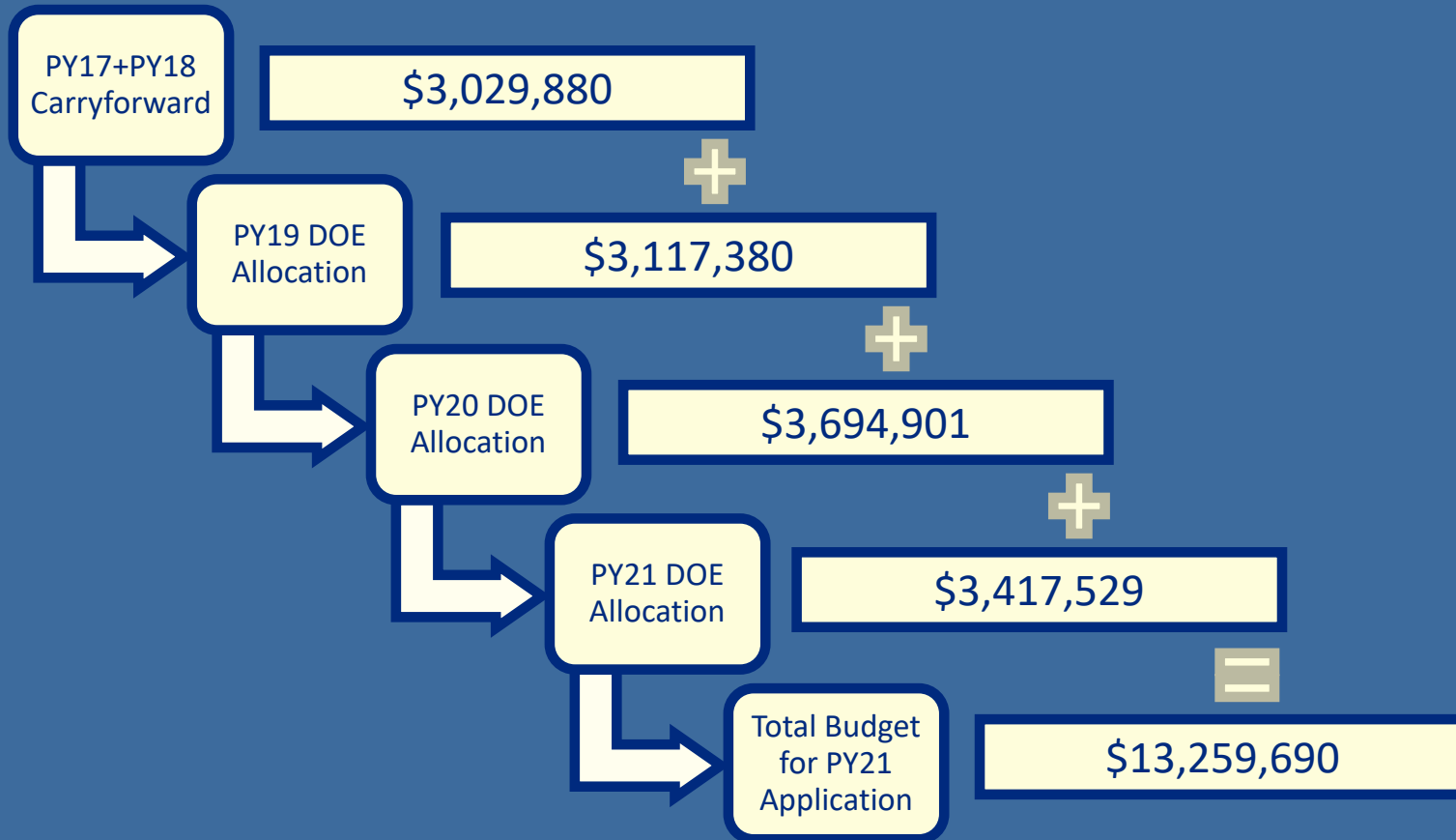
The following programmatic changes will be in effect starting in PY 21:

- Administration Budgets: The budget for administration has increased from 10% to 15%.
- Rolling Re-weatherization Date: All homes which received weatherization services 15 or more years ago from either WAP, LIHEAP, HUD or USDA are now eligible to be re-weatherized by WAP. Ineligible homes are still eligible to receive information on how to save energy and may be serviced by the utility programs.
- Other Notable State Plan Changes: V.7 - Health and Safety, V.8.4 - Training and Technical Assistance Approach and Activities , and V.9 Energy Crisis and Disaster Plan (COVID-19 Updates)



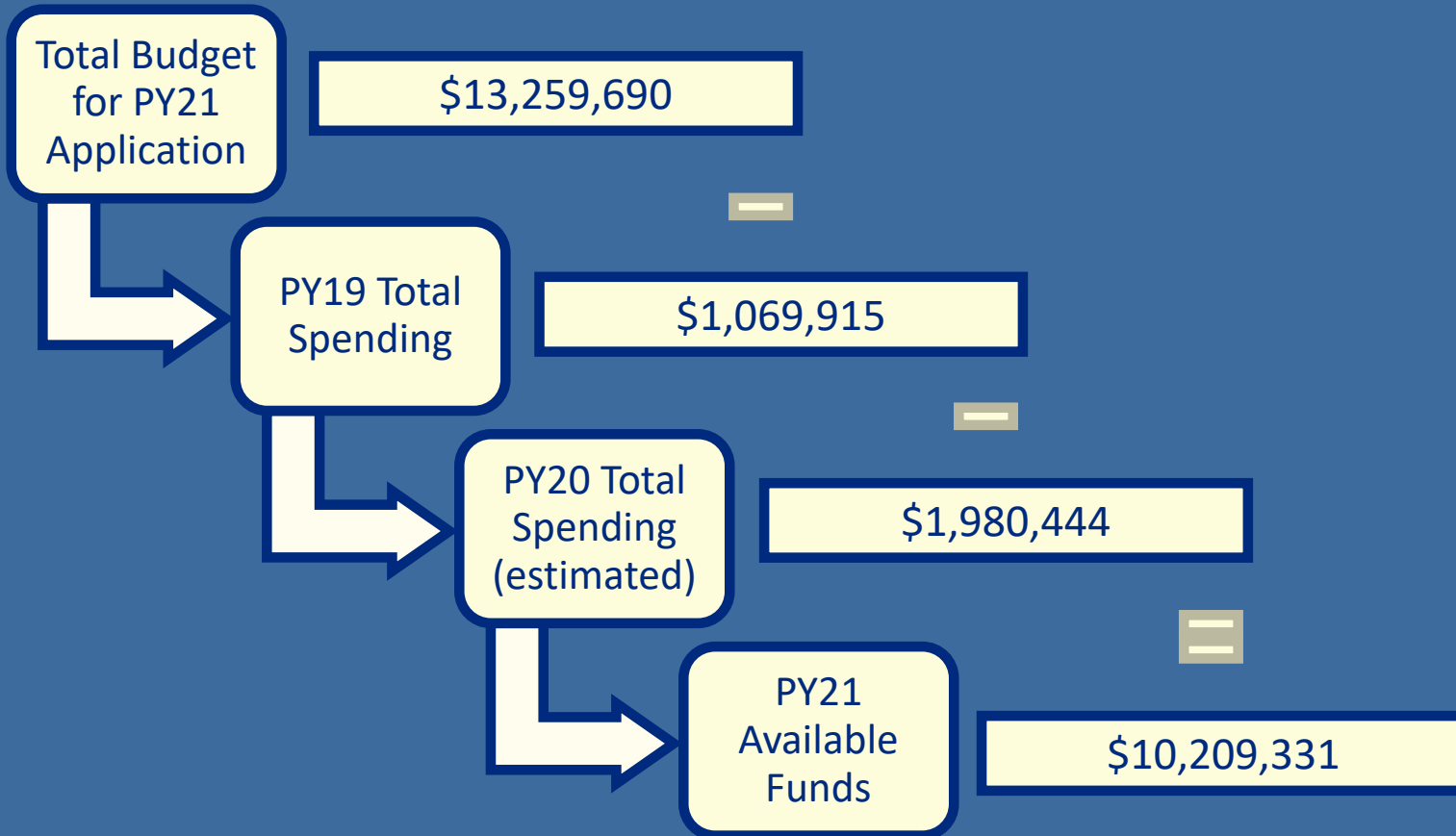

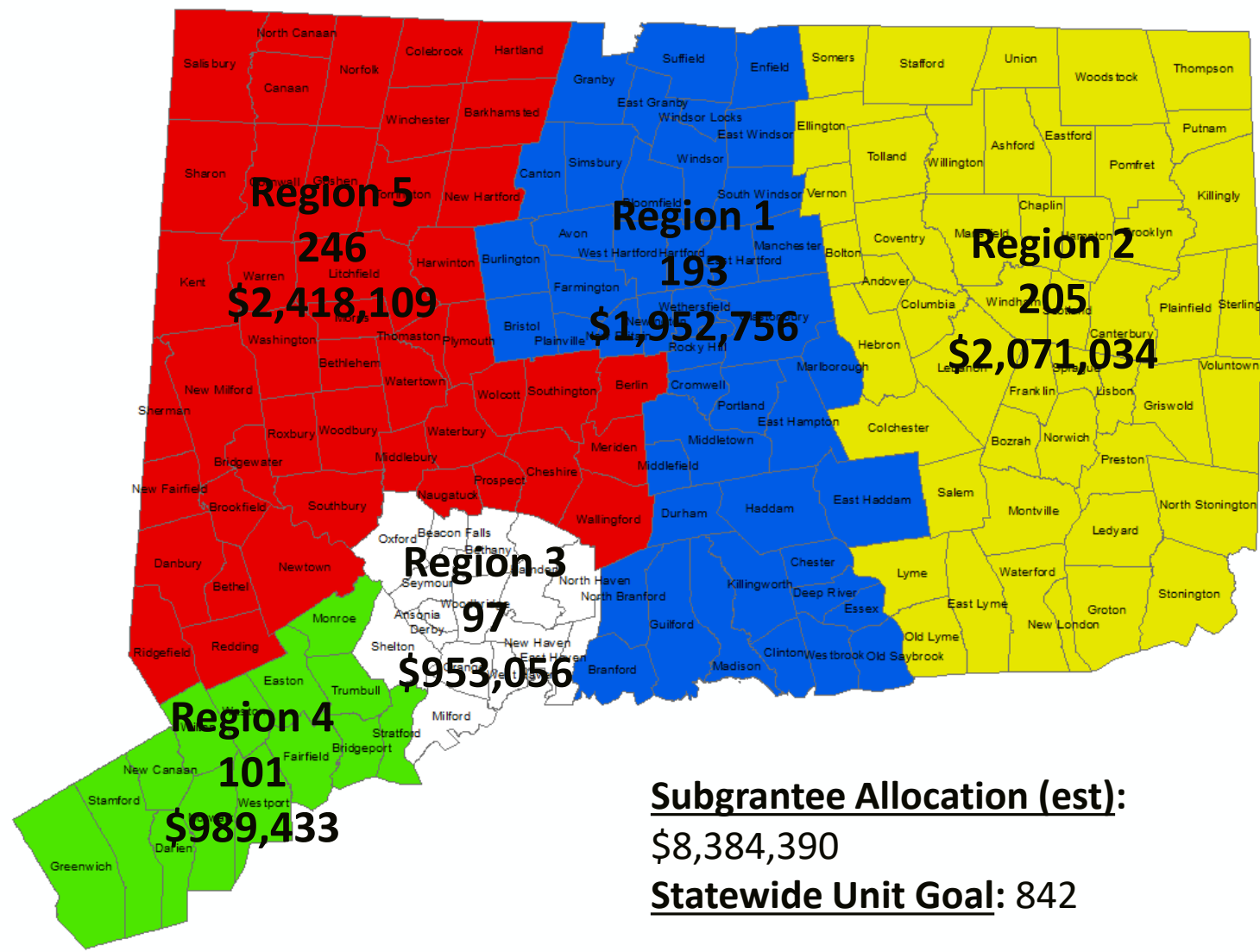
