## Public Informational Meetings: February 26th & 28th

### 2024 Marine Recreational Fishing Regulations

The CT DEEP Marine Fisheries Program (MFP) is holding two Public Informational Meetings to provide information on the status of important recreational fisheries and planned recreational regulations for the 2024 fishing season, as well as to gather public input on 2024 regulation options for scup and summer flounder. The same information will be presented at both meetings. MFP is holding both an inperson and a virtual meeting with identical content in the interest of maximizing opportunities for public participation.

#### **Additional Information**

The Atlantic States Marine Fisheries Commission (ASMFC) and the Mid-Atlantic Fisheries Management Council (MAFMC) jointly manage several fish species on the Atlantic coast, including **scup and summer flounder**. ASMFC and MAFMC have recently voted to implement coastwide changes in recreational regulations for these two species in 2024.

#### Scup (Porgy)

ASMFC and MAFMC have voted to implement a coastwide **10% reduction** in scup recreational harvest for 2024 based on a finding that recreational harvest under "status quo" (i.e., same as 2023) regulations would exceed the 2024 Recreational Harvest Limit (RHL) for scup. States are required to modify their scup recreational regulations to achieve the 10% harvest reduction. The overwhelming majority of scup recreational harvest (>90%) occurs in the states of Massachusetts, Rhode Island, Connecticut, and New York, and the states within this "northern region" have an informal agreement to implement uniform scup recreational regulations for the sake of interstate consistency. DEEP has worked with corresponding agencies in the northern region to develop the following scup regulation options for 2024 (2023 regulations also shown for comparison):

**Option 1**: Increase Boat and For-Hire minimum length by 0.5 inches, no other changes from 2023 regulations.

**Option 2**: Decrease bag limit to 9 fish with exception of a for-hire fall bonus bag limit of 20 fish, no other changes from 2023 regulations.

**Option 3**: Move season opening to April 1, increase all minimum lengths by 0.5 inches, decrease bag limit to 20 fish with exception of a for-hire fall bonus bag limit of 40 fish.

#### **Summer Flounder (Fluke)**

ASMFC and MAFMC have voted to implement a coastwide **28% reduction** in summer flounder recreational harvest for 2024 based on a finding that recreational harvest under status quo regulations would exceed the 2024 Recreational Harvest Limit (RHL) for summer flounder. As in recent years, the Commission and Council opted to allow states or regions to develop state- or region-specific summer flounder regulations to meet the 28% harvest reduction rather than implement uniform coastwide regulations. Connecticut and New York constitute a management region for summer flounder and therefore the two states must adopt identical summer flounder recreational regulations. DEEP has worked with NY Dept. of Environmental Conservation (DEC) to develop the following summer flounder regulation options for 2024 (2023 regulations also shown for comparison):

Minimum Length: 18.5 inchesa

Bag Limit: 4 fish

Season: May 1 - October 9

At this time, DEEP anticipates no changes to recreational size limits, bag limits, or seasons for any species other than scup (porgy) and summer flounder (fluke) in 2024, with the possible exception of a minor one-day adjustment to the season opening date for black sea bass. Regardless, at this meeting, MFP will also provide information on the status of striped bass, black sea bass, bluefish, and tautog (blackfish).
