Directions to Brookfield Town Hall Bandshell, Brookfield, CT

From the south and east: Take US-7 N/Danbury Rd. Follow signs for US-7 N/I-84 E/New Milford/Waterbury and merge onto I-84 E/US-7 N. Exit left 2 lanes to take exit 7 for US-7 N/US-202 E toward Brookfield/New Milford. Take exit 12 for US-202 toward Brookfield. Sharp left onto US-202 W. Turn left onto Silvermine Rd at first light. Turn right onto Pocono Rd at first stop sign. Town Hall is first right.

From the north: Head southwest on US-7 S toward CT-341 W. Take exit 12 for US-202. Turn right onto US-202 W. Turn left at first light onto Silvermine Rd. Turn right onto Pocono Rd at first stop sign. Town Hall is first right.

From the west: Take I-84 East. Exit left 2 lanes to take exit 7 for US-7 N/US-202 E toward Brookfield/New Milford. Take exit 12 for US-202 toward Brookfield. Sharp left onto US-202 W. Turn left onto Silvermine Rd at first light. Turn right onto Pocono Rd at first stop sign. Town Hall is first right.
