# Regular Meeting – January 12, 2023

#### A. <u>Call to Order and Sign-In</u>

A regular meeting of the State Board of Examiners of Environmental Professionals ("the Board") was called to order on Thursday, January 12, 2023 at 9:30 AM in Conference Room 6A, 79 Elm Street, Hartford, Connecticut and via a Zoom conference call, by Acting Chair and Board Administrator Liz McAuliffe. Board members J. Adams, L. Muratore and D. Wolfram and were present in person and M. Gamache, R. Dirienzo` and D. Fiereck were present via Zoom. Selena Thornhill-Moody from DEEP was present in person and Lori DiBella from the Attorney General's Office representing the Board and Nelson Walter representing EPOC were present virtually for the meeting.

# B. Reading and Approval of the Minutes
