Facility and Wastewater Treatment System Modifications

An Environmental Permitting Fact Sheet

Introduction

Facilities change production and treatment system chemicals, as well as modify processes and treatment systems to remain competitive in their respective industries. To ensure the waters of the State and Publicly Owned Treatment Works (POTWs) are protected, prior approval from the Department is necessary before a permittee expands or significantly alters its collection or treatment system or alters or expands its facility in a way that may result in the discharge of any new water, substance or material or increase the quantity or concentration of an existing pollutant beyond permit conditions. The exception to this condition occurs when a permittee must expand or significantly alter its collection or treatment system to correct a permit violation or prevent an imminent permit violation. If this occurs, a permittee may perform treatment system modifications without prior approval and notify the Department afterwards.

The Department performed a “LEAN” initiative on this process, which has stream-lined the process and made the Department more responsive. Providing a complete and detailed notification and request for approval form will help to ensure a relatively short processing time. It’s important to realize that this process should not be utilized when facility changes or treatment system modifications will result in wastewater discharges beyond

permit conditions and limitations. In these situations, a request for permit modification should be pursued instead.


Required Documents
