MGT-310: Threat & Hazard Identification & Risk Assessment (THIRA) & Stakeholder Preparedness Review (SPR) (16 Hours)

This course introduces the six-step THIRA/SPR process which includes identifying threats and hazards that stress a community's capabilities, giving context to those threats and hazards and identifying associated impacts consistent with specific factors, identifying community-specific capability targets, assessing current levels of capability in comparison to those targets, identifying capability gaps and subsequent strategies to close those gaps.

Additional Training Opportunities

Targeted Violence, Domestic Violent Extremism & Prevention (1, 2, or 4 Hours)

These programs will introduce participants to Targeted Violence, the Pathway to Violence Model, Domestic Violent Extremism and Prevention resources. Available programs include a 1-hour briefing, 2-hour overview, and 4-hour course.

FEMA Mission Area(s): Prevent, Protect; Core Capability: Intelligence and Information Sharing

Cybersecurity for Emergency Managers (2 Hours)

This presentation will offer an introduction on cyber issues and concerns as well as to provide information on cyber threats, and ways to reduce cyber risks for yourself and your communities. This is a 2-hour program.

Incident Command System in Schools (2 Hours)

Participants will be introduced to using the ICS in Connecticut schools. The intended audience is anyone expected to assist during a planned event or emergency incident involving the school system. The program will also cover several resources available to schools.

FEMA Mission Area(s): Respond, Recover; Core Capability: Operational Coordination

TERO: Threat Evaluation and Reporting Overview (3 Hours)

Participants will learn about the risk factors, triggers and stressors, and warning behaviors that could impact a person's decision to commit an act of targeted violence. Participants will learn about the mitigating factors

that could help prevent acts of targeted violence, and the importance of community involvement in seeking help for individuals, and respecting their privacy, civil rights, and civil liberties. TERO is an awareness level course for all community members. Additional information is available in Department of Homeland Security program announcement. This is a 3-hour program.

FEMA Mission Area(s): Prevention, Mitigation; Core Capability: Community Resilience

B-TERC: Basic Threat Evaluation and Reporting Course (8 Hours)

Participants will define targeted violence, outline the Pathway to Violence Model and the four-step Behavioral Threat Assessment and Management Model, understand how to identify threats or observable behaviors that may concern others while adhering to individual's constitutional rights, privacy, civil rights, and civil liberties, and recognize the community role in targeted violence prevention. B-TERC is intended for professionals and volunteers who may regularly observe threats or behaviors that may concern others. Additional information is available in Department of Homeland Security <u>program announcement</u>. This is an 8-hour program.

• FEMA Mission Area(s): Prevention; Core Capability: Intelligence and Information Sharing

TERC: Threat Evaluation and Reporting Course (24 Hours)

Participants will define and understand the history of targeted violence, identify the elements and the purpose of the Pathway to Violence Model and learn to apply the four-step Behavioral Threat Assessment and Management Model while adhering to individual's constitutional rights, privacy, civil rights, and civil liberties. TERC is intended for professionals tasked with analyzing and mitigating threats or observable behaviors that may concern others. Additional information is available in the Department of Homeland Security program announcement. This is a 24-hour program, generally delivered over 3 consecutive days.

Emergency Financial First Aid Kit Training (1.5 Hours)

The Emergency Financial First Aid Kit (EFFAK) gives you the peace of mind that your important financial information is at your fingertips. The EFFAK helps you organize critical financial, medical, and household information. It includes a checklist of important documents and forms to compile your relevant information.
