Renovations will be done on the location of the peer respite (on the Southeast Mental Health Authority (SMHA) Campus) to be in compliance with the American with Disabilities Act (ADA). The milieu should consist of a "home-like" setting with appropriate furnishings, decorations, and space to create a welcoming and trauma-informed environment for individuals. The PRP will be comprised of four (4) bedrooms (2 bedrooms for 2 people and 2 single rooms) to accommodate six (6) individuals. One (1) of the bedrooms will be on the first floor. The PRP has a kitchen and cooking space, common area, two (2) full bathrooms and one (1) half bathroom, and storage for food and personal belongings. One (1) of the full bathrooms will be on the first floor.
