

ABANDONED MOTOR VEHICLE SALE NOTIFICATION

H-110 Rev 01-2026

1. Type or clearly print the required information in the fields.

2. If funds are placed in escrow, report the escrow amount and the date such funds were placed in escrow.

3. Email a copy of the completed H-110 Form, along with a copy of the sale receipt, to DMV.reportsale@ct.gov.

4. Provide the original form to the purchaser of the vehicle at the time of sale.

5. If the owner collects the escrowed funds, submit the H-110A form to report the sale within 15 days to DMV.reportsale@ct.gov.

6 If the funds remain unclaimed for one year from the sale date of the motor vehicle, submit H-110A Form to DMV.reportsale@ct.gov.
