**INSTRUCTIONS**

1. Cannot be submitted until sixty (60) days after abandonment by camper(s).
2. Complete all sections.
3. Attach the following:
  - Copies of the mailings to recreational vehicle owner(s), camper(s) (if not recreational vehicle owner), all lienholders and all secured parties and return receipts.
  - Copy of the signed campground agreement between the campground owner and camper(s).
4. Mail original form to the address above with a check or money order made payable to DMV for \$5.
5. Upon receipt, DMV will notify you if the recreational vehicle is approved or rejected for sale via regular mail or e-mail.
