Meeting Called to Order at 9:03AM by Chairperson Jiff Martin

Approve May Meeting Minutes:

Jason White made a motion to approve the May meeting minutes. Ben Freund seconded the motion. Board voted to approve the May meeting minutes. Ellie Angerame abstained.

PDR Programs Report (Cam Weimar):

- 2022 State Fiscal Year recently ended. The Department closed on 16 farms. Fifty-seven percent of project costs came from project partners. We are now at 403 protected farms and a little over 47,000 acres protected. There are 25 farms under agreement covering about 1,700 acres. There are 57 projects in the pipeline covering about 3,800 acres.
- Stewardship is in full swing this summer and fall.
- The Department's Fairfield Hills property is due for a new holder as well as a Department of Corrections property. The Department is having internal discussions

- about the Savin Property and how that property can remain open and available for agriculture.
- Jaime Smith: The Department submitted a project to the SPRB in late June. It was approved in less than four weeks with no questions or concerns from the board.

Jaime Smith provided a presentation to the board outlining changes and updates to the preservation program.

- The Department needs to revise its approach to meet the recent Executive Order that mandates the preservation program close projects within 24 months.
- There will soon be an annual application acceptance period. This would likely be for just one year to allow the Department to catch up on the 57 projects that are in the pipeline.
- The Department is establishing separate tracks for the FLPP and CFPP. All applications must first be scored by the FPP criteria. If it is not eligible for FPP it can then be scored by the CFPP scoring criteria.
- The Department is reconstructing policy and procedures.
- The Department is creating a FLPP research RFP to hire a firm to collect feedback from industry partners, farmland owners, and project partners.

Update on Chair Leadership:

• Robin Chesmer and Jiff Martin will create bylaws for chair leadership and share it with the board at an upcoming meeting.

Agricultural Lands Easement Program (ALE) Discussion:

- Jeffrey Everett shared his views on ALE at the last meeting. He believes that the ALE
 program is very slow and cumbersome. Therefore, New Jersey does not do projects
 with ALE.
- Board discussed how to prioritize ALE funding with the current program funding.
 There were discussions about creating a threshold dollar amount for ALE (i.e. projects estimated to cost above XX amount will trigger an ALE funding application).
- The board discussed wether moving away from ALE for better strategizing its use could support the protection of small and urban farms that are currently bypassed because of soil composition or size.

• The board would like to see a pros/cons list for ALE and to compare timelines for ALE vs. non-ALE projects

Appraisal Issues:

• This conversation is being tabled for a future meeting.

Board Policy Concerns and Recommendations:

- Ben Freund made a motion to put forward the advice that was presented last year regarding OPAV. Joan Nichols seconded the motion with an amendment that the motion state: "The Farmland Preservation Advisory Board (FPAB) advises the Department to create OPAV legislation in the 2022 legislative session." Motion passed.
- Joan Nichols made a motion to advise the Department to conduct an extensive study on the usefulness and potential effects of PDR subdivision before a legislative proposal is brought forth in the 2022 legislative session. Ben Freund seconded the motion. Joan Nichols amended the motion to include that the Department's research be presented to the FPAB. Motion passed.
- Joan Nichols made a motion to hold a special meeting in August, with the Commissioner present, to address policy recommendations on OPAV and the Department's PDR subdivision legislation. Ben Freund seconded the motion. Motion passed.
- Ben Freund made a motion to advise the Department to expand its staff in order to address the needs of smaller farmland preservation applications in support of urban agriculture. Ellie Angerame seconded the motion. Motion passed.

Public comment:

- Chelsea Gazillo discussed with the board a conversation she had with Senator Moore regarding a request to research urban farmland protection programs in other states that work specifically with protecting urban lands that do not have prime or statewide important soils.
- Chelsea Gazillo invited board members to the Farms Under Threat Webinar being hosted on September 9th. This presentation is specific to northeast states.

Joan Nichols made a motion to adjourn the meeting, Ben Freund seconded, meeting adjourned at 11:12PM.

Reconstruction 3: Procedures and processes

- Reestablish and utilize a checklist/excel spreadsheet for the processes, tracking dates, etc.
