## 1,204 Acres

Farmland Permanently Protected



In 2021, the Connecticut Department of Agriculture, in collaboration with partners, permanently protected 1,204 acres across 13 farms in the state, bringing the total number of farmland acres protected in perpetuity to 47,346.



## CT State Plan for Hemp Production Approved by USDA

Agriculture Commissioner Bryan P. Hurlburt announces that the Connecticut Department of Agriculture (CT DoAg) has received approval from the U.S. Department of Agriculture (USDA) for the Connecticut State Plan for Hemp Production. The approved plan supports the Connecticut hemp law and governs registration, production, and compliance for hemp cultivation beginning in 2022.

“USDA’s approval of our state plan for hemp production allows us to align our program with their final rule,” said Hurlburt. “This offers the opportunity for continued growth and diversification necessary for farm sustainability and we look forward to working with producers to administer the program.”

Any growers participating in Connecticut’s program with licenses that expired on December 31, 2021, need to reapply under the new program to grow hemp in 2022. [Applications are now being accepted and more information is available here.](#)

CT DoAg launched the hemp program in May 2019 and since the inception more than 328 acres have been harvested. In 2021, there were 98 licenses issued for 397 licensed lots, including 470,600 square feet of registered indoor hemp growing space and 85 acres planted.

A hemp producer webinar will be held on January 25 from 5:30-6:30 p.m. to review the changes. The Connecticut Agricultural Experiment Station (CAES) in cooperation with USDA APHIS Plant Protection and Quarantine (PPQ) continued to detect expanding populations of the spotted lanternfly (SLF) in Connecticut through 2021. The Director of CAES hereby announces the renewal of the Order of Quarantine for SLF that was established on July 1, 2021, **effective January 1, 2022**. ### THE BIDEN-HARRIS ACTION PLAN FOR A FAIRER, MORE COMPETITIVE, AND MORE RESILIENT MEAT AND POULTRY SUPPLY CHAIN

**The Biden-Harris Administration will dedicate \$1 billion in American Rescue Plan funds for the expansion of independent processing capacity.** USDA reviewed [nearly 450 comments](#) received over the summer in response to its request for input on how best to increase independent processing capacity. Through their analysis of stakeholder input, USDA identified an urgent need to:

- Expand and diversify meat and poultry processing capacity;
- Increase producer income;
- Provide producers an opportunity to have ownership in processing facilities;
- Create stable, well-paying jobs in rural regions;
- Raise the bar on worker health, safety, training, and wages for meatpacking jobs;
- Spur collaboration among producers and workers;
- Prompt state, tribal, and private co-investment; and

### DEADLINES APPROACHING FOR NRCS FY2022 CONSERVATION FUNDING OPPORTUNITIES

The U.S. Department of Agriculture (USDA) is announcing the fiscal year 2022 assistance opportunities for agricultural producers and private landowners for key programs, such as the [Environmental Quality Incentives Program](#) (EQIP); [Conservation Stewardship Program](#) (CSP); [Agricultural Conservation Easement Program](#) (ACEP) - Agricultural Land Easement (ACEP-ALE), Wetlands Reserve Easement (ACEP-WRE); [Regional Conservation Partnership Program](#) (RCPP); and [Agricultural Management Assistance](#) (AMA) program. While USDA's Natural Resources Conservation Service (NRCS) accepts applications for these programs year-round, producers and landowners should apply by state-specific ranking dates to be considered for this year's funding. ### **SIX COUNTIES APPROVED FOR FEDERAL AGRICULTURE DISASTER DECLARATION DUE TO HURRICANE IDA**

On Dec. 21, Governor Ned Lamont announced that he has received notice from U.S. Department of Agriculture Secretary Tom Vilsack that an agriculture disaster declaration has been approved for portions of Connecticut due to the impact of the remnants of Hurricane Ida on the state in early September.

The declaration will make farmers in six of the state's counties – including Hartford, Middlesex, New Haven, New London, Tolland, and Windham – eligible to be considered for certain disaster assistance from the Farm Service Agency to cover production losses from the storm, such as emergency loans, provided that eligibility requirements are met. While Middlesex and New London are named as primary counties in the declaration, the other four are named as contiguous disaster counties, making farmers in all six of those named counties eligible for assistance.

Farmers will have eight months from the date of the secretarial disaster declaration to apply for emergency loans. The Farm Service Agency considers each emergency loan application on its own merits, taking into account the extent of production losses on the farm and the security and repayment ability of the operator. Farmers interested in applying for the assistance must contact [their local Farm Service Agency office](#).

In August, a similar federal agriculture disaster declaration [was approved](#) for Connecticut as a result of the damages caused by Tropical Storm Elsa, which impacted the state in early July. That particular declaration applies to all eight of the state's counties, and farmers statewide are still eligible to apply for assistance under it.

## EDA GOOD JOBS CHALLENGE DEADLINE EXTENDED

The Good Jobs Challenge is designed to support the needs of an applicant's identified regional workforce system through a single integrated award. EDA will make awards to either the System Lead Entity of a regional workforce system or the Backbone Organization of a sectoral partnership as the lead applicant. These organizations may make sub-awards to other eligible recipients as necessary to the proposed project and as approved by EDA. **The deadline to apply has been extended to February 10, 2022.**

Eligible applicants for EDA's Good Jobs Challenge include a(n):

- District Organization;
- Indian Tribe or a consortium of Indian Tribes;
- State, county, city, or other political subdivision of a State, including a special purpose unit of a State or local government engaged in economic or infrastructure development activities, or a consortium of political subdivisions;
- Institution of higher education or a consortium of institutions of higher education; or
- Public or private non-profit organization or association, including labor unions, acting in cooperation with officials of a political subdivision of a State

Individuals or for-profit entities, including for-profit institutions of higher education, are not eligible.

## **USDA LAUNCHES LOAN GUARANTEE PROGRAM**

U.S. Department of Agriculture (USDA) Secretary Tom Vilsack announced USDA is deploying \$100 million under the new Food Supply Chain Guaranteed Loan Program to make available nearly \$1 billion in loan guarantees; these loan guarantees will back private investment in processing and food supply infrastructure that will strengthen the food supply chain for the American people.

USDA is making the funding available through the American Rescue Plan Act. The program is part of the Biden-Harris Administration's efforts to address food system challenges dating back decades and further exacerbated by the COVID-19 pandemic. These investments will help essential processing and supply chain infrastructure that will ultimately deliver more opportunities and fairer prices for farmers, they will give people greater access to healthier foods, and they will help eliminate bottlenecks in the food supply chain.

#### **Food Supply Chain Guaranteed Loan Program**

Through the Food Supply Chain Guaranteed Loan Program, USDA will partner with lenders to guarantee loans of up to \$40 million to help eligible entities expand meat and poultry processing capacity and finance other food supply chain infrastructure. Lenders may provide the loans to eligible cooperatives,

USDA Rural Development (RD) will administer the loans. Funding may be used to:

- start-up or expand food supply chain activities such as aggregating, processing, manufacturing, storing, transporting, wholesaling or distributing food.
- address supply chain bottlenecks.
- increase capacity and help create a more resilient, diverse and secure U.S. food supply chain.

### DEADLINE EXTENDED FOR CERTIFIED ORGANIC AND TRANSITIONING OPERATIONS TO APPLY FOR PANDEMIC SUPPORT

The U.S. Department of Agriculture (USDA) has extended the deadline for agricultural producers who are certified organic, or transitioning to organic, to apply for the Organic and Transitional Education and Certification Program (OTECP). This program provides pandemic assistance to cover certification and education expenses. **The deadline to apply for 2020 and 2021 eligible expenses is now Feb. 4, 2022**, rather than the original deadline of Jan. 7, 2022.

### RMA PUBLISHES PROPOSED CHANGES TO THE APPLE CROP INSURANCE POLICY

The U.S. Department of Agriculture (USDA) announced publication of a proposed rule in the *Federal Register* to amend the Apple Crop Provisions. The proposed changes are based on stakeholder feedback and recommended changes from a contracted study on the apple crop insurance program. Following feedback from the proposed rule, USDA's Risk Management Agency (RMA) will publish a final rule that is expected to be effective for the 2023 crop year.

RMA is proposing to make changes to the apple crop insurance program that:

- Enable producers to elect different coverage levels and percent of price elections by type, which allows producers to manage individual coverage and price risk more effectively.
- Allow producers' premiums to be reduced in response to orchard management practices, such as removing or grafting trees, that typically occur after the acreage reporting date and decrease an orchard's productivity.

- Exclude apples sold for the slicer market from being considered “fresh apple production.”
- Introduce a fresh fruit factor to account for the reduced market value of production insured under the Quality Option sold for a grade other than U.S. Fancy.
