

ORDER IMPOSING FINE

DOCKET NO. CRF-18-8238-S

#### I. PRELIMINARY STATEMENT

WHEREAS, the Banking Commissioner ("Commissioner") is charged with the administration of Chapter 672a of the General Statutes of Connecticut, the Connecticut Uniform Securities Act ("Act"), and Sections 36b-31-2 to 36b-31-33, inclusive, of the Regulations of Connecticut State Agencies ("Regulations") promulgated under the Act;

WHEREAS, the Commissioner, through the Securities and Business Investments Division of the Department of Banking ("Department"), conducted an investigation into the activities of Allied Energy, Inc., f/k/a Allied Syndications, Inc. ("Respondent"), pursuant to Section 36b-26(a) of the Act, to determine if Respondent had violated, was violating or was about to violate provisions of the Act or Regulations ("Investigation");

WHEREAS, on April 25, 2018, based on the Investigation, the Commissioner, acting pursuant to subsections (a), (b) and (d) of Section 36b-27 of the of the 2018 Supplement to the General Statutes ("2018 Supplement"), issued an Order to Cease and Desist, Order to Make Restitution, Notice of Intent to Fine and Notice of Right to Hearing against Respondent (collectively, "Notice"), which Notice is incorporated by reference herein;

WHEREAS, on April 27, 2018, the Notice was sent by certified mail, return receipt requested, to

WHEREAS, on May 7, 2018, the April 27, 2018 Mailing was returned to the Department of Banking marked "Forward Time Exp – RTN to Send : Allied Energy Inc – 8201 Peters Rd Ste 1000 – Plantation FL 33324-3266 – Return to Sender";

WHEREAS, on May 8, 2018, a copy of the Notice was sent by certified mail, return receipt requested, to Respondent at 8201 Peters Road, Suite 1000, Plantation, Florida 33324-3266 ("May 8, 2018 Mailing");

WHEREAS, according to the United States Postal Service Tracking system, the May 8, 2018

Mailing was "Delivered, Left with Individual – Fort Lauderdale, FL 33324 – Your item was delivered to an individual at the address at 12:26 pm on May 11, 2018 in Fort Lauderdale, FL 33324";

WHEREAS, on June 8, 2018, the Notice was served on the Commissioner, and on June 13, 2018, in accordance with Section 36b-33(h) of the General Statutes of Connecticut, Notice of Service on the Banking Commissioner In the Matter of: Allied Energy, Inc. f/k/a Allied Syndications, Inc., dated June 13, 2018 ("Notice of Service"), was sent by certified mail, return receipt requested, to Respondent at 2427 Russellville Road, Bowling Green, Kentucky 42101; and 8201 Peters Road, Suite 1000, Plantation, Florida 33324-3266;

WHEREAS, Respondent has failed to request a hearing on the allegations set forth in the Notice within 14 days of the date of the Notice of Service;

WHEREAS, on July 11, 2018, a Certification was issued rendering the Order to Cease and Desist and Order to Make Restitution permanent as of June 28, 2018, which Certification is incorporated by reference herein:

WHEREAS, Section 36a-1-31(a) of the Regulations provides, in pertinent part, that:

When a party fails to request a hearing within the time specified in the notice, the allegations against the party may be deemed admitted. Without further proceedings or notice to the party, the commissioner shall issue a final decision in accordance with section 4-180 of the Connecticut General Statutes and section 36a-1-52 of the Regulations of Connecticut State Agencies, provided the commissioner may, if deemed necessary, receive evidence from the department, as part of the record, concerning the appropriateness of the amount of any . . . fine [or] restitution . . . sought in the notice.

**WHEREAS**, Section 36b-31(a) of the Act provides, in pertinent part, that "[t]he commissioner may from time to time make . . . such . . . orders as are necessary to carry out the provisions of sections 36b-2 to 36b-34, inclusive";

AND WHEREAS, Section 36b-31(b) of the Act provides, in pertinent part, that "[n]o... order may be made... unless the commissioner finds that the action is necessary or appropriate in the public interest or for the protection of investors and consistent with the purposes fairly intended by the policy and provisions of sections 36b-2 to 36b-34, inclusive."

### II. FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. The Commissioner finds that the facts as set forth in paragraphs 7 through 18, inclusive, of the Notice, shall constitute findings of fact within the meaning of Section 4-180(c) of the General Statutes of Connecticut and Section 36a-1-52 of the Regulations, and that the Statutory Basis for Order to Cease and Desist, Order to Make Restitution and Order Imposing Fine set forth in paragraphs 19 through 24, inclusive, of the Notice shall constitute conclusions of law within the meaning of Section 4-180(c) of the General Statutes of Connecticut and Section 36a-1-52 of the Regulations.
- 2. The Commissioner finds that Respondent committed at least one violation of Section 36b-16 of the Act, and materially aided SE Ohio Shale & Oriskany Development's violation of Section 36b-6(b) of the Act by employing and allowing an unregistered agent to solicit investors on behalf of SE Ohio Shale & Oriskany Development.
  - 3. The Commissioner finds that the facts require the imposition of a fine upon Respondent.
- 4. The Commissioner finds that the Notice complied with the requirements of Section 36b-27 of the 2018 Supplement and Section 4-177 of the General Statutes of Connecticut.
- 5. The Commissioner finds that the imposition of a fine upon Respondent is necessary and appropriate in the public interest and for the protection of investors and consistent with the purposes fairly intended by the policy and provisions of Sections 36b-2 to 36b-34, inclusive, of the Act.

#### III. ORDER

Having read the record, I hereby **ORDER**, pursuant to Section 36b-27(d) of the 2018 Supplement, that:

- 1. A fine of Ten Thousand Dollars (\$10,000) shall be imposed upon Allied Energy, Inc., f/k/a Allied Syndications, Inc., such fine to be remitted to the Department by cashier's check, certified check or money order, made payable to "Treasurer, State of Connecticut", no later than forty-five (45) days from the date this Order Imposing Fine is mailed; and
- 2. This Order Imposing Fine shall become final when mailed.
