From the Commissioner



You know you have been around for a long time when the agency is preparing to commemorate the 30th anniversary of one of our most important units, and I was part of it when it all began. I am referring to CERT, the Correctional Emergency Response Team, which is set to celebrate three decades of being always ready to respond and protect our agency when the going gets difficult and dangerous. A CERT muster to

mark the anniversary will be held on June 16, 2012 at the Webster Correctional Center. This will be an event that is open to the public and Lieutenant Governor Nancy Wyman will be able to drop by and help us recognize this achievement. As for the history involved here, the agency learned the hard way, during a major riot at the then Somers State Prison in 1982, that we didn't have a sufficient inhouse response ready when something like this occurred. We had to call in the Connecticut State Police that night to quell the actions of the inmates. In the wake of that incident, the Department went to work and created the first CERT Team of which I was a member.

The Comptroller went on to share some statistics regarding the use of health care. In 2010, 76% of all state employees age 50 and above received preventive health care; when looking at just correctional employees from

the same age group, the percentage drops to 46%. The good news is that the number of correctional employees receiving preventative care in 2011 jumped dramatically to 66%.

"When so many people are fighting for access to the kind of care that we (as state employees) have, we are obligated to use the benefits that are in front of us," Lembo added.

The recipient of the Highest Scholastic Award for the class was Correction Officer Gabriel Rivera with a final grade average of 99.04%. The members of Class 251 selected Lieutenant Juan Martinez as the recipient of the Victor E. Harris, Jr. award, named for a deceased officer whose enthusiastic dedication and commitment to correctional education and training still lives on in the memory of DoC staff.

In addition to swearing the members of Class 251, Commissioner Leo C. Arnone also took the opportunity to officially swear in two new Deputy Wardens, Sandra Barone of the MacDougall Walker

Thank you – From a Warden and a Friend



On May 11, 2012, the staff of the Corrigan Radgowski Correctional Center was informed of the loss of one of their Officers, Matt Yacovou. Matt had just shy of 18 years in the Department, all of which were at CRCC. Matt was a former member of the Correctional Emergency Response Team, and was currently assigned as the Key and Tool Officer.

There are over 100 staff members assigned to this facility who were Matt's classmates. As you can imagine, this impacted the facility greatly.

With the approval and cooperation of the Executive Team, NP-4 and NP-8 unions, we were able to arrange for a CTU bus to transport staff for the wake and funeral. We were able to obtain enough volunteer coverage for both days to send all the staff that remained on duty to be able to pay their respects and attend the services. None of this would have been possible if it were not for the support of the Executive Team, NP-4 and NP-8, and especially the staff that volunteered their time and traveled to CRCC to take post so their correctional brothers and sisters could say good bye to their co-worker and friend. In all, 49 staff volunteered and took post so CRCC staff could attend the services. Some of the staff had actually worked at the facility before, many of them had not.

This is the largest undertaking of this nature that I have experienced during my 23 plus years in this agency. I requested permission to have a bus, and staff from other facilities to come volunteer to take post on Monday afternoon. By Tuesday mid-morning, I had received final approval to ask the other wardens for assistance. In less than 24 hours we had received enough responses back from staff from all over the state willing to volunteer and take post so that CRCC staff could attend.

Words cannot express what this meant to the staff of CRCC, Matt's family, and myself. These were a couple of the most painful days I had experienced as part of this Agency. I had to say goodbye to a friend, and still be a warden at the same time. I would not have been able to do it without receiving the support I did from everyone. On behalf of the CRCC staff, as well as Matt's family, I want to thank everyone for their assistance - we always come together in times of need. These were painful days, but also, proud days, to see the Agency work as one to assist their brothers and sisters, strangers with a common bond, the Connecticut Department of Correction.

Police Unity Tour

The Police Unity Tour originated in 1997 with the purpose of increasing public awareness as well as to memorialize the men and women of law enforcement who have died in the line of duty. The funds generated are intended to pay for the National Law Enforcement Museum Hall of Remembrance which is scheduled to be opened in 2013. The motto of the ride is, "We ride for those who died." The riders and support staff had to raise a minimum of \$1750 to participate in the ride. This year a total \$1.65 million was raised for National Law Enforcement Memorial

Legislators Tour Willard-Cybulski

On Wednesday May 16, 2012, Warden John Tarascio and his administrative team hosted a legislative tour of the Willard/Cybulski facility for Senator John Kissel, D.C. at the National Law Enforcement Memorial. The Enfield Town Council Member Tom Arnone, Somers Deputy Fire Chief Frank Falcone and Lt. Reynolds.

The warden provided a power point presentation of the facility's statistics including program and treatment services the inmates are offered to prepare them for their re-entry to the community upon their release. Programs include worship services, academic and vocational training, Tier II, NA, AA, Voices, Anger Management, Thinking for a Change, and Parenting classes. Warden Tarascio spoke about the importance of the facility's involvement in community projects to provide work assistance to the surrounding towns. He provided an overview of the Commissioner's Farming Initiative and the gardens at WCCI, which reduce food costs and provide fresh produce to local food shelters. Plant facility engineer Kevin Roy provided an overview of the Maintenance Department and SSDH Mary Kane spoke on behalf of the education programs.

After the presentation, the guests were given a guided tour of the facility.

Corrigan-Radgowski CC Opens J's Barn

With patches of newly sawn wooden shingles standing out against its turn of the century walls, Warden Scott Erfe recently led the dedication ceremony at the Corrigan-Radgowski Correctional Center for J's Barn, which will be the site of a new rehabilitation program for abused, large animals.

With staff, department leaders and representatives of partners in the project from the Department of Agriculture in attendance, Erfe explained the restored barn is named after three staff and the town resident who milled the lumber, all he thought, had first names beginning with the letter "J". They include Officers Jason Ware, Joe Schoonmaker and Jesse Long. The warden had those gathered laughing, as he admitted he didn't find out until the

day before the event, that the saw mill owner's name Gerry Shaffer began with a "G".

The program will build upon the success of the Second Chance Corral on the grounds of the York Correctional Institution, to which the Agriculture Department has for a number of years taken animals seized in animal abuse cases. The sick and malnourished animals are nursed back to health with the assistance of inmate labor. This new facility will be easier for those interested in adopting to come and see the animals.

Erfe thanked DOC officials including Commissioner Leo Arnone, Deputy Commissioners Cheryl Cepelak and James Dzurenda and District Administrators Michael LaJoie and Angel Quiros for letting him think out

of the box about establishing the program at his facility.

The project has been carried out at no expense to state taxpayers. The lumber used to renovate the existing barn was cut on the facility property and milled without cost. The work was carried out by staff and inmate labor.

The program expands the agricultural theme already in full swing at the Uncasville facility where three gardens are already in early bloom and two goats and a flock of chickens are already at home.

Two horses, whom Erfe called his lifers, already have a new home in the barn. Venus and Rebel, with a history of abuse and a number of ailments, will be well cared for at J's Barn.


