## **New Sex Offender Registry Debuts with DOC Help**



Attorney Kevin Kane, and Governor M. Jodi Rell were among those on-hand for the unveiling of the new Sex Offender Registry web site.

With the click of a mouse, Governor M. Jodi Rell has debuted a thoroughly enhanced version of the State's on line Sex Offender Registry. At an unveiling news conference at Connecticut State Police headquarters, Commissioner Brian K. Murphy and Department of Correction staff were recognized for their assistance in the process.

The website allows the public to literally put a two mile circle around their home, or any other location, such as their children's school to determine if there are registered sex offenders in the area. If offenders are in the area, their photograph and full background information is provided. E-mail notifications can also be requested for a particular address, should a sex offender move into the area. The system will also indicate if a registered sex offender is currently incarcerated.

DOC staff who participated in the project include Correctional Counselor Supervisor George Camp of the Offender Classification and Population Management Unit and Parole Manager Eric Ellison of the Parole and Community Services Division. The new Sex Offender Registry site can be accessed through the Department of Correction website, under "Other Resources" on the lower right hand toolbar.

In recent, highly constructive and congenial, meetings with both the NP-4 officers' union and the NP-8 managers' union, we discussed insuring that basic correctional concepts are carried out. In both cases the unions were in full agreement that we need to reinforce those core correctional concepts.

The third piece is reentry. While other states are struggling with ever growing correctional populations and the rising related costs, Connecticut has been a leader in managing the size of our population. We have been able to do this primarily through our reentry mission, by providing offenders with opportunities that support successful community reintegration.

This mission has been recently aided by the legislature's reinstatement of reentry furloughs with a new 45day duration. Studies conducted in Connecticut have shown that a period of supervision in the community prior to an offender's end of sentence significantly increases the chances for successful reentry. From a population high after the Cheshire tragedy, we are now down more than 1,000 offenders and we are continuing to see the inmate population drop. By placing appropriate offenders in the community, under supervision prior to the end of their sentence, we have not only improved their chances of not returning to us and thereby reducing recidivism, but we have also enhanced public safety as offenders comply with the law abiding expectations of our communities. Reentry will continue to be one of the core programs, as we go forward doing more with less, we will continue to emphasize. So while the faces and the agency continue to change, our mission will remain the same-we shall stay the course, and see our success continue.

Commissioner Brian K. Murphy was recently inducted into Eastern Connecticut State University's "E-Club" Hall of Fame for his career as a pitcher for the school's baseball team.

Murphy, a 20-game winner who led Div. III in victories as a junior All-American selection, pitched exclusively at the subvarsity level as a freshman in 1976 and developed into the team's stopper on varsity in his final two seasons.

In his junior and senior seasons, the lefty won 20 of 25 decisions with a 2.09 ERA in 1761D 3 innings and won all three of his decisions in NCAA regional tournament competition. He was voted the team's Best Pitcher twice and its MVP once. The 16th E-Club Hall of Fame Induction Ceremony took place on October 25, at the Betty R. Tipton Room in the ECSU Student Center in Willimantic.

#### **Preparing your Lawn for Winter**


At the end of the summer your lawn is tired, and so are you, but don't quit yet! There are several important things that must be done before winter to ensure that you have a healthy lawn next spring.

One of the most important steps in preparing your lawn for winter is to continue to cut your grass until there has been no visible growth for about two weeks. Although growth has stopped, the root system of the grass is still growing, and must be cared for. On your final cut of the year, you should leave you lawn about two inches high.

This height is important because if grass is left too high, about 3 inches plus, it will lay down on itself or be blown over by winter snow and wind. Once this happens, the grass retains an excessive amount of moisture, and may develop diseases such as snow mold.

If your grass is cut too short, about one inch or under, the crown of the grass is unprotected from the elements. Harsh winds and even the winter sun can end up damaging the crown of the grass.

After your grass is cut for winter, don't let leaves accumulate and sit over the winter. Leaves lying on the grass all winter can trap moisture and cause grass to rot, or in some cases block moisture from even reaching the grass. De-thatching removes debris from the grass surface and optimally you should aerate your grass before winter to help fertilizer absorb into the ground.



Once your grass is cut and leaves are cleared, it is a good idea to then fertilize your lawn. Grass roots stay alive during the winter, and need care also. This is especially important after a rainy summer where water tends to drain the soil of nutrients. Sustain-released fertilizers help supply grass with nitrogen, phosphorus, and potassium for the winter. An optional step is to also use lime on your grass. Lime comes in pellets or power, and will help to sweeten your lawn and adjust the pH if your lawn is too acidic.

Finally, remember to properly store your lawn care equipment. It is a good time to clean, sharpen, and grease mowers, rotor-tillers, and other tools. Spending some time to care for your equipment now can make starting up in the spring much easier.

By taking the time to care for your lawn in the fall, you encourage healthy lawn growth and avoid headaches in the spring.


#### Condolences

#### Just(ice) Rewards

For his outstanding efforts in supporting the investigation and prosecution of significant criminal cases during the past year, retired Department of Correction Lieutenant Sean Sullivan was honored during the 2009 United States Attorney's Award Ceremony.

Hosted by Acting United State's Attorney for the District of Connecticut, Nora Dannehy hosted the ceremony was held on October 23, at the Connecticut Police Academy in Meriden.

The investigation which the Department of Correction in general, and Lt. Sullivan specifically, were involved in centered around organized crime's control of Connecticut's trash industry. As a result of the lengthy investigation, all of the 34 defendants pleaded guilty. One of the ringleaders, James E. Galante, was sentenced to 87 months of prison time. In addition, more than two million dollars in unpaid taxes have been collected as a result of the investigation.
