Special Recognition The Department of Correction Garners two Awards from Special Olympics

Eastern Regional Director Marc Mercadante said, "Under the direction of Warden Kevin Gause and Lieutenant Eric Dessaules, York CI has put together a committee that takes on fundraising events such as the LETR Basketball Tournament at St. Bernard's School, the Tri-town Cop on Top, the VFW Tip-A-Cop, Tip-A-Cop at Waterford Dunkin Donuts, the York CI Poker Ride, the most recent Over the Edge event held at Mohegan Sun and various other fundraisers. Also, each year, they recruit 25-30 runners and walkers to participate in leg 2 of the annual law enforcement torch run. In the last five years York CI has raised \$90,000 to benefit Special Olympics and is always there to support the Eastern Regional events, this truly makes them deserving of this award."

Unsung No More

Captain Penn has been involved with Special Olympics since 2001, and has served as the Town Captain and Leg 2 Coordinator for the Law Enforcement Torch Run. She was the first correction officer and woman to complete a three-day Cop on Top fundraising event. Since 2001, Captain Penn has helped staff members of the Corrigan-Radgowski facility raise more than \$40,000 to benefit Special Olympics. In the words of her nominator, "she has shown a true dedication to our athletes and our mission with her efforts."

The event was hosted by the Bozzuto and Calvanese families, with Brad Field of NBC Connecticut and Renee DiNino of Clear Channel Community Access Radio served as the emcees for the event.

Staff members of the Department of Correction were the recipients of not one, but two awards during the Special Olympics Connecticut Hall of Fame Awards Dinner. The annual event which honors outstanding athletes, volunteers and supporters was held on March 21, at the Aqua Turf Country Club in Plantsville, CT. What should not come as much of a surprise considering the staff's yearlong commitment to the cause, the York Correctional Institution received the award for the Outstanding Organization for the Eastern Region. In addition the "group" award, Captain Theresa Penn of the Corrigan-Radgowski Correctional Center received an Unsung Hero Award, to volunteers who work tirelessly behind the scenes to benefit Special Olympics.

The Bridgeport Reentry Collaborative is a voluntary association of more than 40 local and state agencies that have worked together since 2007 to create a comprehensive network of services for men and women returning from incarceration to the greater Bridgeport community.

Collaborative Research Grant Update

For the past year and a half the Connecticut Department of Correction has been working in partnership with the University of Connecticut School of Nursing and UCONN Health Center on a three-year federal grant-funded project to build up infrastructure for research and evaluation at the Department of Correction (DoC).

It is hoped that the results of this project will enhance criminal justice researcher-practitioner partnerships and facilitate projects that will be beneficial to the department. Research and evaluation at the DoC will lead to evidence-based practices to validate what the agency is doing well, reveal things that it could do differently, while discovering cost-effective solutions.

Three teams are working toward the goals of this grant: Leadership, Education & Training, and Information Technology/Management Information Systems. The working teams expect to see several changes implemented as a result of their efforts:

- 1) Planning and carrying out research at the DOC will be easier. The application and approval process will be spelled out more clearly, and may be posted on a website.
- 2) Uniform data elements and codebooks will be made accessible to DOC staff and researchers. The grant is supporting the expansion of Connecticut Health Information Network (CHIN) to include the DOC and Correctional Managed Health Care CMHC data and to link these data with information from other state agencies, including the Departments of Public Health, Children and Families, and Developmental Services.
- 3) In addition, more DOC staff members will be encouraged to discuss implementing the outcomes of research and evaluation projects to benefit facility practices.

Members of CT DOC staff who are involved on all three teams of this partnership are Deputy Commissioner Cheryl Cepelak; Colleen Gallagher, Health Services Program Director for Health and Addiction Services; and Michelle Altomare, Associate Research Analyst. Dan Bannish, Health Services Program Director; and Pat Hynes, Ph.D., Director of Best Practices Unit, participate on the Leadership Team. While Tracey Butler, Director of Human Resources and Training, along with Warden Jose' Feliciano are on the Education & Training Team. Bob Cosgrove, Director of Management Information System, works with the IT/MIS Team. Brian Garnett, Director of External Affairs, has provided very helpful feedback as well. From the UCONN Health Center, Robert Trestman, Professor and Executive Director of the Correctional Managed Health Care division (CMHC), sits on the Leadership Team. Robert Aseltine, Professor and Director of CHIN and the Institute for Public Health Research, is on the IT Team, along with Pat Cooney, Applications Developer, and Mike Vasquenza, Director of IT for CMHC. Michael Nicholson, CMHC Director for Education, participates on the Education & Training Team.



From the UCONN School of Nursing, Deborah Shelton, Professor, is the Project Director; William Barta is the Evaluator, and Nancy Dittes is Research Coordinator. Megan Ehret, Assistant Professor at the UCONN School of Pharmacy, works with the Education and Training Team.


