Dzurenda will directly supervise Administration, Budget and Planning, Human Resources, Information Technology, Facilities Planning and Support Services, and Labor Relations.

Commissioner Dzurenda was appointed Commissioner by Governor Dannel P. Malloy in November 2013 and was confirmed unanimously by the State Senate during the 2014 Legislative Session.

Dzurenda leaves with more than 27 years of experience working in various positions at the State of Connecticut Department of Correction. His career began in May 1987 as a Correction Officer at the Bridgeport Correctional Center, progressively assuming positions of greater administrative responsibility as a Correctional Lieutenant, Correctional Captain, Correctional Major, Correctional Warden, South District Administrator, and Deputy Commissioner of Operations.

"I am grateful to Governor Malloy and Lt. Gov. Nancy Wyman for giving me the opportunity to run the state's largest agency," Dzurenda said. "Governor Malloy and his administration have been great supporters of the agency's vital mission of protecting the public."

Governor Malloy has appointed Deputy Commissioner Scott Semple to serve as Interim Commissioner of the agency. By appointing Semple, who has 26 years of correctional experience, Malloy said he's confident the agency will continue to operate safely and efficiently during the transitional period. Commissioner Semple was immediately faced with the task of addressing the

District Administrator Peter Murphy will oversee facilities in Districts #2 and #3.

Director Karl Lewis to Acting Director of Programs and Treatment.

Counselor Supervisor Gavin Galligan will oversee the Offender Classification Population Management Unit.

Our continued success as an agency relies on our organizational values, performance, and professional integrity. I look forward to working with all of you.

Second Chance at Carl Robinson CI

Building on the Department of Correction's proud track record of providing care for neglected animals, the Carl Robinson Correctional Institution has recently joined the ranks of other facilities such as the Niantic Annex and the Corrigan-Radgowski Correctional Center. For the past few months, Carl Robinson has been the foster home for both a horse named Hickory and a donkey named Eyore. Both animals were abused and neglected prior to their rescue.

Second Chance Rescue, a non-profit organization located in Granby, Connecticut, stepped in to give these animals a fighting chance at survival. It was at this point, Carl Robinson agreed to foster the animals until they could be placed in a nurturing home. Second Chance Rescue provides all of the feed and veterinary care.



The program is being used to help inmates learn about responsibility and ownership. They maintain a strict schedule of feeding, grooming, and exercise. They are also responsible for maintaining cleanliness in the barn and stalls. Using patience, they are teaching the animals commands that will increase their chances of adoption.

Hickory is now a beautiful, healthy and gentle horse - who is set to be adopted soon. Eyore is still learning, but making progress. He was found in a crate and is still learning trust. Officer Lisa Darlington oversees the daily care of the animals, in addition to supervising the inmates, she has been a true advocate for the animals. A dedicated professional, officer Darlington has been instrumental in the success of the project.

Father Bruno Named "Chaplain of the Year"

Rev. Anthony J. Bruno, Director of Religious Services for the Department of Correction, as well as the two term past President of the American Correctional Chaplains Association (ACCA), has been selected by the Salvation Army to receive their highest award as the "Chaplain of the Year". The Salvation Army bestowed this prestigious national honor for distinguished service in the field of corrections during the American Correctional Association's annual Summer Congress of Correction in Salt Lake City, Utah on August 19, 2014.

This is not the first time Reverend Bruno has received a national award. Back in 2008, Reverend Bruno was awarded the E. R. Cass Correctional Achievement Award by the American Correctional Association

Reverend Bruno is one of fewer than 25 active ACCA certified correctional chaplains in the entire country and also one of fewer than ten chaplains certified by the American Catholic Correctional Chaplains Association (ACCCA), another national certifying body. Reverend Bruno is also the former ACCA Chancellor, a current member of the ACCA Executive Council, former Chair and current member of the ACA Religious Faith Based Services Committee, and current member of the ACA Certification Committee and the ACCCA Certification Committee.

Senior Tactical Council Members Sought

Through retirement, promotions and attrition, Tactical Operations finds itself losing staff at an alarming rate. While extremely well trained, there is no substitute for experience. As of today, many of the tactical leaders are retiring or have been promoted to positions where they no longer have a role within the tactical community. The end result is that the foundation of experience and knowledge, which is so heavily depended upon, ultimately leaves the unit. Recognizing this, the Tactical Operations Unit is seeking volunteers to serve as Senior Tactical Council members that meet the following criteria:

Qualifications

- A) Non-current members of Tactical Operations must have served on a Tactical Unit for not less than five (5) years.
- B) Non-current members of Tactical Operations must have held a leadership position within the Tactical Unit that they are representing.
- C) Final appointment of non-current members of Tactical Operations is at the discretion of the Statewide Tactical Executive Officer in consultation with the Director of Tactical Operations.

Responsibilities

- A) Meetings will address emergent issues within the tactical units, current training initiatives and specific concerns of any tactical commander.
- B) Meetings will include a component designed to educate the current commanders about previous disturbances in our Department's history that required mass deployment of tactical operators, and how those disturbances were handled, how they were resolved, and what could have been done differently for swifter resolution.
- C) Meetings will periodically include tabletop drills designed by the Statewide Executive Tactical Officer in consultation with the former tactical members of the Council.
- D) Meetings will periodically include After Action Review of trainings, drills and live deployments of current tactical staff.


