Designated VIP Coordinators will arrange interviews, background screening & your overall evaluation as a potential correctional volunteer. After being interviewed by a facility VIP Coordinator, your application materials will be forwarded to the Supervisor of Volunteer Services Unit for review. All applicants will receive "official" approval or denial from the Supervisor of the Volunteer Services Unit. Please become familiarized with the VIP Handbook.
