Dear Attorney Fulco,

On October 1, 2019, the Regulatory and Compliance unit of the Connecticut Department of Transportation provided notice of applications for certificates of public convenience and necessity ("Certificates") filed by First Transit Inc. ("First Transit") pursuant to Conn. Gen. Stat. §13b-80. The notice relates to First Transit seeking Certificates for the routes it is currently operating under a contract with the Connecticut Department of Transportation ("Department"), specifically Routes 101, 102, 128 and 913.

The Regulatory and Compliance unit is in receipt of submissions that are two distinct letters from you, both dated October 29, 2019, on the above referenced First Transit applications. Attached to your letters are petitions for

hearings on each of the applications filed on behalf of your clients, DATTCO, Inc. ("DATTCO"), The New Britain Transportation Company, Inc. ("NBT"), and Collins Bus Service, Inc. ("Collins").

Below is a summary of the October 29, 2019 submissions to the Regulatory and Compliance unit. In the submissions, there are some discrepancies between the text of the letter and the attachments, that I would like to set out.

The first letter indicates that six petitions were attached. Those petitions were identified as:

2. Petition of Collins Bus Service, Inc., in Docket No. 1909-FR-05-B (101);

However, upon review, the following ten petitions were attached to your first letter:

Along a similar line, your second letter indicates that six petitions were attached. The petitions attached to the second letter matched the petitions as stated in your second letter. They are:

2. Petition of DATTCO, Inc., Docket No. 1909-FR-106-B (102) Fastrack;
3. Petition of The New Britain Transportation Company, Inc., Docket No. 1909-FR-106-B (102) Fastrack;
4. Petition of DATTCO, Inc., Docket No. 1909-FR-107-B (128) Fastrak;

5. Petition of The New Britain Transportation Company, Inc., Docket No. 1909-FR-107-B (128) Fastrak;

6. Petition of Collins Bus Service, Inc., Docket No. 1909-FR-108-B (913) Fastrak.

The language in each petition appears to be substantially similar to the other petitions. In each petition, NBT, DATTCO, and Collins claim that they own Certificates, specifically Certificates 10, 11, and 303 and 466, respectively.

The Regulatory and Compliance Unit will not be holding a hearing on the First Transit Applications. Conn. Gen. Stat. §13b-80 states that the Department "may" hold a hearing on a petition that is submitted under Conn. Gen. Stat. §13b-80. Legislation enacted in 1997 (Public Act 97-304) eliminated the requirement of a mandatory public hearing on petitions. Therefore, Conn. Gen. Stat. §13b-80 does not require a hearing but leaves it to the discretion of the Department. The Department will give all entities that have submitted comments on the Applications, including NBT, DATTCO and Collins, the opportunity to submit any additional information they believe should be considered in relation to the Applications.

In addition, the Regulatory and Compliance Unit requests that your clients, NBT, DATTCO and Collins, provide a response to the request for information below, separately for each petition.

- Please identify (a) each route listed in the petitioner's Certificate that is incorporated and/or runs parallel to the route sought by First Transit in the Application; (b) the streets listed in each of petitioner's Certificated routes over which the First Transit route operates; and (c) the streets listed in each of in the petitioner's Certificated routes over which the First Transit route operates and which the petitioner also operates fixed route bus service.

All responses to the request for information listed above and any additional information must be submitted to the Regulatory and Compliance Unit no later than February 7, 2020. You may contact me at felipe.briseno@ct.gov if you have any questions.
