### Connecticut's Beach Tier Classification Guide

<u>Classification</u>	<u>Definition</u>	<u>Notes</u>
<b>Tier I</b>	Meets the minimum recommended sampling requirements and frequency and <u>No more than one closure occurrence during previous bathing season.</u>	Sampled weekly; <b>and</b> 0 or 1 closure event/season
<b>Tier II</b>	Meets the minimum recommended sampling requirements and frequency and <u>No more than three closure occurrences during the bathing season.</u>	Sampled weekly; <b>and</b> 2 or 3 closure events/season
<b>Tier III</b>	Does not meet minimum recommended sampling requirements and frequency or <u>more than three closures</u> occurrences during the bathing season or <u>beaches not monitored</u> .	<b>Not</b> sampled weekly; <b>or</b> more than 3 closure events/season
