

## Connecticut Department of Public Health Radon Program List of Radon Measurement Providers

The State of Connecticut, Department of Public Health (CT DPH) is required under Connecticut General Statute §19a-14b, to “maintain a list of companies or individuals that are included in current lists of national radon proficiency programs.” The following lists contain the names of individuals holding the Residential Measurement Provider certification from one of the two national certifying agencies for radon professionals: (1) the [AARST National Radon Proficiency Program](#) (NRPP) or (2) the [National Radon Safety Board](#) (NRSB). Radon Measurement Providers have demonstrated knowledge of U.S. EPA and/or ANSI/AARST radon measurement protocols for the placement and retrieval of radon measurement devices. They have also demonstrated knowledge of the proper interpretation of results obtained in residential settings.

The CT DPH does not license or register individuals who perform radon measurement in residential properties. Consumers may choose to hire a nationally certified radon measurement professional from this list. The CT DPH cannot be responsible for the knowledge or experience of providers of services, nor for their fees or business practices. Inclusion on this list does not constitute an endorsement of the individuals or companies. People are encouraged to take normal business precautions before selecting a professional.

There are two types of **Radon Measurement Providers** listed:

1. *Residential Measurement Service Providers* offer radon measurement services to consumers including, but not limited to, radon detector placement, home inspection, and consultation. These individuals or companies do not have the ability to directly analyze radon in a home. Devices must be submitted to an “Analytical Service Provider” or laboratory, as described below.
2. *Analytical Service Providers* have *their own analysis capabilities* for radon measurement. The listed individual or company is:
  - An individual or company that utilizes a radon measurement device (a *continuous radon monitor* or *electret ion chamber*) that allows for the direct measurement and reporting of radon in a home without the services of an analytical laboratory (analytical service provider); or
  - An analytical laboratory that sells test kits (passive devices) to residential measurement service providers or homeowners and analyzes and reports the results of testing to a residential measurement service provider or homeowner.

Consumers may obtain additional information on radon professionals and their analytical capabilities by visiting the NRPP and NRSB websites.

### Overview of Testing Devices for Radon in Air

There are several devices available that can be used to measure radon in air. The measurement of radon in homes requires a minimum time of 48 hours for testing, preceded by 12 hours of closed house conditions (as required by the U.S. EPA). The following is a brief overview of these devices:

**Passive devices** do not require power to operate. A residential measurement service provider or analytical measurement service provider may be hired to conduct testing using these devices. It is recommended that you hire a trained technician for placing and retrieving devices. **Short Term** testing is a period from 2-90 days; **Long Term** testing is a period of 91 days to 1 year.

**Active devices** require power to operate. A trained technician should be hired to ensure accurate radon testing results. The most used active device is a Continuous Radon Monitor which gives hourly readings over a period of 48 hours.

### Water Services for Your Private Well:

Radon measurement professionals listed are qualified to collect water samples for radon analysis. Water samples collected by radon measurement professionals must be submitted to a laboratory approved by the CT DPH Environmental Laboratory Certification Program. Please refer to the CT DPH [List of Approved Labs for Radon-in-Water Analysis](#).

The decision to reduce radon in your water should be based on the average of two valid water sample results. Refer to “[Radon in Your Well Water](#)” for Connecticut’s guidance on radon in private well water.
