## 2013 Connecticut Electronic Filing Payment Voucher

**Purpose:** Complete **CT-1065/CT-1120SI V** if you filed your Connecticut composite income tax return electronically and **elect to make payment by check**. You must pay the total amount of tax due on or before the fifteenth day of the fourth month following the close of the taxable year (April 15 for calendar year filers). Any unpaid balance will be subject to penalty and interest.

**Pay by Mail:** Make check payable to **Commissioner of Revenue Services**. To ensure payment is applied to the correct account, write "2013 CT-1065/CT-1120SI V e-file" and the PE's Federal Employer Identification Number (FEIN) on the front of the check. Sign the check and clip it to the front of the voucher. Do not send cash. The Department of Revenue Services (DRS) may submit the check to your bank electronically. Return the voucher below with your payment.

### Other Payment Options

**A. Pay Electronically:** Visit [www.ct.gov/TSC](http://www.ct.gov/TSC) to use the **Taxpayer Service Center (TSC)** to make a direct tax payment. After logging into the **TSC**, select the *Make Payment Only* option and choose a tax type from the drop down box. Using this option authorizes DRS to electronically withdraw a payment from your bank account (checking or savings) on a date you select up to the due date. As a reminder, even if you pay electronically, you must still file your return by the due date. Tax not paid on or before the due date will be subject to penalty and interest.

**B. Pay by Credit Card or Debit Card:** You may elect to pay your 2013 tax liability using a credit card (American Express®, Discover®, MasterCard®, VISA®) or comparable debit card. A convenience fee will be charged by the service provider. You will be informed of the amount of the fee and may elect to cancel the transaction. At the end of the transaction, you will be given a confirmation number for your records.

There are three ways to pay by credit card or comparable debit card:

- Log in to your account in the **TSC** and select *Make Payment by Credit Card*;
- Visit [www.officialpayments.com](http://www.officialpayments.com) and select *State Payments*; **or**
- Call Official Payments Corporation toll-free at **800-2PAY-TAX** (800-272-9829) and follow the instructions. You will be asked to enter the Connecticut Jurisdiction Code: 1777.

Your payment will be effective on the date you make the charge.
