General Instructions

Use this form to report and pay Connecticut use tax and Connecticut alcoholic beverage tax on alcoholic beverages you:

- Brought into Connecticut that you purchased or were given outside of Connecticut; **or**
- Are having shipped into Connecticut that you purchased or were given outside of Connecticut.

For more information on the importation of alcoholic beverages into Connecticut, call the Excise Taxes Unit at 860-541-3224, Monday through Friday, between 8:30 a.m. and 4:30 p.m. You must complete this form and file it with DRS at the address on the front, together with either **Form BT-100, Application for Permission to Import Alcoholic Beverages From Within the United States for Personal Consumption**, or **Form BT-101, Application for Permission to Import Alcoholic Beverages From Outside the United States for Personal Consumption**, to import alcoholic beverages into Connecticut.

Instructions for Completing Form S&BT

- You must complete *Schedule A* (below) first in order to complete the total amount of tax due on the front of this form.
- On the front of this form, Lines 1 through 6, Column E, enter the amount you paid for the untaxed alcoholic beverages including shipping and handling charges.
- If you paid sales or use tax to another jurisdiction on your purchase of untaxed alcoholic beverages, enter on Line 10 on the front of this form the amount of sales or use tax paid to the other jurisdiction as long as the invoice or slip shows the amount of tax paid to the other jurisdiction.
- You must attach an original or a photocopy of the invoice or numbered slip issued at the time of purchase to this form.
