NOTICE RE DEPARTMENT OF PUBLIC HEALTH WEBPAGE

In addition to the filing instructions contained in the March 7, 2013 Notice of Hearing in the above-referenced matter, the Parties shall also send any correspondence, including motions, via email to DPH at DPH.Acquisitions@ct.gov. The date and time of filing shall be the date and time the DPH first receives a complete electronic version or the paper version and the required number of paper copies.

The Departments presume that all documents filed with them are subject to the right of public inspection and copying in accordance the Connecticut Freedom of Information Act, *Conn. Gen. Stat. § 1-200 et seq.* ("FOIA"). Please note that if a party believes that a document or portion of a document filed with the Departments may be withheld from disclosure in accordance with FOIA, it may file a Motion for a Protective Order ("Motion") requesting an exemption from public disclosure. The Motion shall provide specific legal arguments with reference to state or federal law describing with supporting facts why the information should be kept confidential. A certified affidavit supplied by a competent witness in support of the Motion, a proposed protective order and nondisclosure agreement must be appended to the Motion.

The confidential material itself must be submitted in hard copy only to the Departments for *in camera* review by the Departments. Each page of the confidential information shall be stamped “CONFIDENTIAL,” and the material shall be placed in a sealed envelope marked “CONFIDENTIAL – NOT FOR PUBLIC DISCLOSURE.” Do not send any proposed confidential information electronically to the Departments.
