

Available CPR/AED and Bleeding Control Training Equipment

The State of Connecticut Department of Public Health, Office of Emergency Medical Services (OEMS), was able to purchase a significant amount of training equipment with federal grant money obtained through the HEARTSafe Program. Locations of equipment have been established throughout the state. Each location has been provided with:

20 Adult CPR Manikins, 20 Infant CPR Manikins, 20 AED Training units, 10 Adult Ambu Bags, 10 Infant Ambu Bags and 7 (2 Person) Bleeding Control Training Kits. **Please note that this equipment is only available for not for profit training.**

The equipment remains the property of the HEARTSafe program but is on loan to each location listed above. Each organization listed is allowed to use the equipment and, in exchange, they house and loan out the equipment when requests are made. A priority is to be given to school based CPR training as the equipment was purchased to support legislation that requires CPR be added to the curriculum for middle and secondary schools.
