SUBJECT: FGX International Recalls Children's Sunglasses Due to Violation of Lead Paint Standard

On September 4, 2014, the Consumer Product Safety Commission (CPSC) issued a recall of 20 styles of Disney, Marvel and Sears/Kmart brand children's sunglasses. They come in a variety of colors and with printed images of characters on the frames. The following style numbers located inside the sunglasses' left temple arm are included in the recall:
