What is CIRTS?

- 1993 started as a city-wide registry in Hartford
- 1994 authorized registry by the state
- 1998 **Statewide** automatic enrollment
 - "Opt-Out" registry for parents
 - Mandated reporting for pediatric providers
- 2012 *new* web-based immunization registry
- 2013 building capability for EHR reporting

 - a list of patients assigned to your facility

- Reminder Report (due)
 - a list of patients in your facility and their 'due'
 immunizations (from the forecasting) for each vaccine
- Recall Report (overdue)
 - a list of patients in your facility and their 'overdue' immunizations (from the forecasting) for each vaccine
